## **HOUSE BILL No. 5429**

January 18, 2018, Introduced by Reps. Marino, Farrington, Lucido and Graves and referred to the Committee on Military and Veterans Affairs.

A bill to amend 1893 PA 206, entitled
"The general property tax act,"
by amending section 7b (MCL 211.7b), as amended by 2013 PA 161.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 7b. (1) Real—SUBJECT TO SUBSECTION (2), REAL property
  used and owned as a homestead by a—ANY OF THE FOLLOWING INDIVIDUALS

  IS EXEMPT FROM THE COLLECTION OF TAXES UNDER THIS ACT:
  - (A) A disabled veteran who was discharged from the armed forces ARMED FORCES of the United States under honorable conditions. or by an individual described in subsection (2) is exempt from the collection of taxes under this act.
  - (B) A SURVIVING SPOUSE OF A DISABLED VETERAN WHO, IMMEDIATELY
    BEFORE DEATH, WAS ELIGIBLE FOR THE EXEMPTION UNDER THIS SECTION. AN

- 1 EXEMPTION UNDER THIS SUBDIVISION CONTINUES AS LONG AS THE SURVIVING

- 20 (B) "SERVICE-CONNECTED DISABILITY" MEANS A DISABILITY INCURRED
- 21 OR AGGRAVATED IN THE LINE OF DUTY IN THE ACTIVE MILITARY, NAVAL, OR
- 22 AIR SERVICE AS DESCRIBED IN 38 USC 101(16).
- 23 (C) "VETERAN" MEANS A PERSON WHO SERVED IN THE ACTIVE
- 24 MILITARY, NAVAL, MARINE, COAST GUARD, OR AIR SERVICE AND WHO WAS
- 25 DISCHARGED OR RELEASED FROM HIS OR HER SERVICE WITH AN HONORABLE OR
- 26 GENERAL DISCHARGE.
