January 31, 2018, Introduced by Rep. Kosowski.

A bill to amend 1965 PA 380, entitled "Executive organization act of 1965,"

(MCL 16.101 to 16.608) by adding section 130.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 130. (1) THE DEPARTMENT SHALL PARTNER WITH THE DEPARTMENT
- 2 OF HEALTH AND HUMAN SERVICES TO ESTABLISH A JOINT ADVISORY
- 3 COMMITTEE THAT WILL DEVELOP AND IMPLEMENT THE INITIATIVE DESCRIBED
- 4 IN SUBSECTION (2). COMMITTEE FORMATION AND MEMBERSHIP SHALL BE
- 5 JOINTLY DETERMINED BY THE DEPARTMENT AND THE DEPARTMENT OF HEALTH
- 6 AND HUMAN SERVICES.
- 7 (2) THE COMMITTEE SHALL DEVELOP AND IMPLEMENT A JOINT
 - INITIATIVE TO INCREASE AWARENESS AMONG THE VETERANS AND FAMILY

- 1 (2)(C) SHALL INCLUDE A CONSPICUOUSLY PLACED DISCLAIMER STATING THAT
- 2 THE PROVISION OF GUIDANCE OR INFORMATION REGARDING VETERANS'
- 3 PROGRAMS AND BENEFITS THAT MAY BE AVAILABLE TO THE INDIVIDUAL
- 4 RECEIVING THAT GUIDANCE OR INFORMATION IS FOR INFORMATIONAL
- 5 PURPOSES ONLY AND IS NOT AN INDICATION OR DETERMINATION OF
- 6 ELIGIBILITY FOR THOSE PROGRAMS OR BENEFITS.
- 7 (4) THE DEPARTMENT MAY SHARE WITH THE DEPARTMENT OF HEALTH AND
- 8 HUMAN SERVICES INFORMATION IN ITS POSSESSION THAT IS RELATED TO THE
- 9 NEEDS OF VETERANS AND FAMILY MEMBERS OF VETERANS IF NECESSARY TO
- 10 FACILITATE THE INITIATIVE DESCRIBED IN THIS SECTION, UNLESS SHARING
- 11 THAT INFORMATION IS A VIOLATION OF A STATE OR FEDERAL LAW

- 14 (A) "COMMITTEE" MEANS THE JOINT ADVISORY COMMITTEE ESTABLISHED
- 15 UNDER SUBSECTION (1).
- 16 (B) "DEPARTMENT" MEANS THE DEPARTMENT OF MILITARY AND VETERANS
- 17 AFFAIRS.
- 18 Enacting section 1. This amendatory act takes effect 90 days
- 19 after the date it is enacted into law.
- 20 Enacting section 2. This amendatory act does not take effect
