A bill to amend 1967 PA 281, entitled

"Income tax act of 1967,"

(MCL 206.1 to 206.713) by adding section 254.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 254. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
- 2 2018, A TAXPAYER WHO IS A SENIOR CITIZEN OR PERSON WITH
- 3 DISABILITIES OR WHO HAS A SENIOR CITIZEN OR PERSON WITH
- 4 DISABILITIES RESIDING WITHIN HIS OR HER HOME MAY CLAIM A CREDIT
- 5 AGAINST THE TAX IMPOSED BY THIS PART EQUAL TO 50% OF THE COST PAID
- 6 BY THE TAXPAYER, NOT TO EXCEED \$5,000.00, FOR QUALIFIED RENOVATIONS
- 7 MADE TO THE HOME OF THE TAXPAYER.
- 8 (2) THE CREDIT ALLOWED UNDER THIS SECTION SHALL BE TAKEN ONLY
  - IN THE TAX YEAR IN WHICH THE QUALIFIED RENOVATIONS FOR WHICH A

- 11 (B) "QUALIFIED RENOVATIONS" MEANS RENOVATIONS, ADDITIONS, OR
- 12 OTHER CONSTRUCTION MADE TO A HOME THAT ARE ANY OF THE FOLLOWING:
- 13 (i) CHANGES TO PROVIDE MOBILITY ASSISTANCE AND ACCOMMODATE THE
- 14 PHYSICAL NEEDS OF A SENIOR CITIZEN OR PERSON WITH DISABILITIES,
- 15 INCLUDING, BUT NOT LIMITED TO, BATH BARS, RAMPS, SAFETY FEATURES,
- 16 DOOR WIDENING, ACCESS CHANGES, WHEELCHAIR LIFTS, STAIRWELL LIFTS,
- 17 AND REFITTING OF FIXTURES.
- 18 (ii) ANY CHANGE TO THE HOME THAT IS MADE TO MEET LOCAL OR
- 19 STATE BUILDING CODES, ORDINANCES, STATUTES, OR RULES THAT REGULATE
- 20 HOUSING FOR PERSONS WITH DISABILITIES.
- 21 (C) "PERSON WITH DISABILITIES" MEANS THAT TERM AS DEFINED IN
- 22 SECTION 103 OF THE PERSONS WITH DISABILITIES CIVIL RIGHTS ACT, 1976
- 23 PA 220, MCL 37.1103.
- 24 (D) "SENIOR CITIZEN" MEANS AN INDIVIDUAL WHO IS 60 YEARS OF
- 25 AGE OR OLDER AT THE CLOSE OF THE TAX YEAR.
