ENDANGERED SPECIES TRAFFICKING

3	SEC. 36701. (1) AS USED IN THIS PART:
4	(A) "SELL" MEANS TO SELL, TRADE, OR BARTER, FOR MONETARY OR

- 14 YEAR OR A FINE OF NOT MORE THAN \$2,000.00, OR BOTH.
- 15 (2) IN ADDITION TO THE CRIMINAL PENALTIES SET FORTH IN THIS
- 16 SECTION, A PERSON THAT VIOLATES SECTION 36702, UPON CONVICTION, MAY
