January 18, 2017, Introduced by Senator KNEZEK and referred to the Committee on Finance.

A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

(MCL 206.1 to 206.713) by adding section 277.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 277. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
- 2 2017, A TAXPAYER WHO IS A TEACHER WHO TEACHES AT A PUBLIC SCHOOL
- 3 MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED BY THIS ACT EQUAL TO THE
- 4 COST PAID BY THE TAXPAYER IN THE TAX YEAR NOT TO EXCEED \$1,000.00
- 5 FOR A SINGLE RETURN OR \$2,000.00 FOR A JOINT RETURN FOR CLASSROOM
- 6 SUPPLIES USED BY THE TAXPAYER FOR EDUCATIONAL PURPOSES THAT
- 7 DIRECTLY RELATE TO THE TAXPAYER'S CLASSROOM COURSE WORK AT THE
- 8 PUBLIC SCHOOL.
- 9 (2) IF THE CREDIT ALLOWED UNDER THIS SECTION EXCEEDS THE TAX
- 10 LIABILITY OF THE TAXPAYER FOR THE TAX YEAR, THAT PORTION THAT
- 11 EXCEEDS THE TAX LIABILITY SHALL NOT BE REFUNDED.
