- 5 appropriations for the fiscal year ending on September 30, 2019
- 6 2020 for the items listed in section 236. The fiscal year 2018-2019
- 7 2019-2020 appropriations are anticipated to be the same as those
- 8 for fiscal year <del>2017-2018,</del> **2018-2019,** except that the amounts will
- 9 be adjusted for changes in caseload and related costs, federal fund
- 10 match rates, economic factors, and available revenue. These
- 11 adjustments will be determined after the January 2018 2019
- 12 consensus revenue estimating conference.
