SENATE BILL No. 909

March 15, 2018, Introduced by Senators KNOLLENBERG, HORN, COLBECK and HANSEN and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 553a, 1231, 1233, 1233b, and 1531i (MCL 380.553a, 380.1231, 380.1233, 380.1233b, and 380.1531i), section 553a as amended by 2011 PA 277, section 1231 as amended by 2016 PA 192, section 1233 as amended by 2017 PA 151, section 1233b as amended by 1995 PA 289, and section 1531i as added by 2009 PA 202.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 553a. (1) An authorizing body may issue a contract to establish a school of excellence that is a cyber school. A cyber school shall provide full-time instruction to pupils through online learning or otherwise on a computer or other technology, and this

- 1 instruction and learning may occur remote from a school facility.
- 2 (2) A contract for a school of excellence that is a cyber
- 3 school shall include all of the provisions required under section
- 4 553 and all of the following:
- 5 (a) A requirement that a teacher who holds appropriate
- 6 certification according to state board rule OR WHO IS ENGAGED TO
- 7 TEACH UNDER SECTION 1233B will be responsible for all of the
- 8 following for each course in which a pupil is enrolled:
- 9 (i) Improving learning by planned instruction.
- 10 (ii) Diagnosing the pupil's learning needs.
- 11 (iii) Assessing learning, assigning grades, and determining
- 12 advancement.
- 13 (iv) Reporting outcomes to administrators and parents or legal
- 14 guardians.
- 15 (b) A requirement that the cyber school will make educational
- 16 services available to pupils for a minimum of at least 1,098 hours
- 17 during a school year and will ensure that each pupil participates
- 18 in the educational program for at least 1,098 hours during a school
- **19** year.
- 20 (3) Notwithstanding any other provision of this act or any
- 21 rule, if a school of excellence that is a cyber school is in
- 22 compliance with the requirements of subsection (2)(a) regarding a
- 23 certificated teacher OR A TEACHER ENGAGED TO TEACH UNDER SECTION
- 24 1233B, any other adult assisting with the oversight of a pupil
- 25 during the pupil's participation in the cyber school's education
- 26 program is not required to be a certificated teacher, A TEACHER
- 27 ENGAGED TO TEACH UNDER SECTION 1233B, or an employee of the school.

- 1 (4) Notwithstanding any rule to the contrary, a cyber school
- 2 is not required to comply with any rule that would require a
- 3 pupil's physical presence or attendance in a classroom.
- 4 (5) At the end of a cyber school's second complete school year
- 5 of operations, the authorizing body of a school of excellence that
- 6 is a cyber school shall submit to the superintendent of public
- 7 instruction and the legislature, in the form and manner prescribed
- 8 by the superintendent of public instruction, a report detailing the
- 9 operation of the cyber school, providing statistics of pupil
- 10 participation and academic performance, and making recommendations
- 11 for any further statutory or rule change related to cyber schools
- 12 and online learning in this state.
- Sec. 1231. (1) Except as otherwise provided in subsection (5),
- 14 the board of a school district shall hire and contract with
- 15 qualified teachers. Contracts with teachers shall be in writing and
- 16 signed on behalf of the school district by a majority of the board,
- 17 by the president and secretary of the board, or by the
- 18 superintendent of schools or an authorized representative of the
- 19 board. The contracts shall specify the wages agreed upon.
- 20 (2) A teacher's contract shall be filed with the secretary of
- 21 the board and a duplicate copy of the contract shall be furnished
- 22 to the teacher.
- 23 (3) Except as otherwise provided under this act, a contract
- 24 with a teacher is not valid unless the individual holds a valid
- 25 teaching certificate OR IS ENGAGED TO TEACH UNDER SECTION 1233B at
- 26 the time the contractual period begins or the individual is engaged
- 27 to teach in a community district under section 1233c. A contract

- 1 shall terminate if the certificate expires by limitation and is not
- 2 renewed immediately or if it is suspended or revoked by proper
- 3 legal authority.
- 4 (4) The board of a school district, after a teacher has been
- 5 employed at least 2 consecutive years by the board, may enter into
- 6 a continuing contract with a certificated teacher OR A TEACHER
- 7 ENGAGED TO TEACH UNDER SECTION 1233B or, for a community district,
- 8 with an individual engaged to teach in a community district under
- **9** section 1233c.
- 10 (5) The school—board of a school district that is a community
- 11 district may employ or contract for, or both, qualified teachers
- 12 and other qualified instructional personnel at a public school that
- 13 formerly operated as an achievement school, as defined in section 3
- 14 of the state school aid act of 1979, MCL 388.1603, as necessary to
- 15 carry out the purposes of the community district.
- 16 (6) As used in this section: , "teacher"
- 17 (A) "ACHIEVEMENT SCHOOL" MEANS A PUBLIC SCHOOL FORMERLY WITHIN
- 18 THE EDUCATION ACHIEVEMENT SYSTEM THAT WAS OPERATED, MANAGED,
- 19 AUTHORIZED, ESTABLISHED, OR OVERSEEN BY THE ACHIEVEMENT AUTHORITY.
- 20 (B) "TEACHER" does not include a substitute teacher.
- 21 Sec. 1233. (1) Except as otherwise provided by law, and
- 22 subject to section SECTIONS 1233B AND 1233c, the board of a school
- 23 district or intermediate school board of an intermediate school
- 24 district shall not permit a teacher who does not hold a valid
- 25 teaching certificate to teach in a grade or department of the
- 26 school.
- 27 (2) The board of a school district or intermediate school

- 1 board of an intermediate school district shall not allow an
- 2 individual to serve in a counseling role in the school district or
- 3 intermediate school district, as the role is defined by the
- 4 superintendent of public instruction, unless the individual meets 1
- 5 or more of the following:
- 6 (a) The individual holds a valid teaching certificate with a
- 7 school counseling endorsement.
- 8 (b) The individual meets all of the following:
- 9 (i) Holds a master's degree awarded after completion of an
- 10 approved school counselor education program that includes at least
- 11 all of the following skills and content areas or their equivalent:
- 12 (A) Guidance services--philosophy, principles, and practices.
- 13 (B) Individual and group analysis--nature and range of human
- 14 characteristics and appraisal methods.
- 15 (C) Guidance information--vocational development theory,
- 16 educational and occupational information.
- 17 (D) Counseling theory and practice--individual and group
- 18 procedures, administration and coordination relationships,
- 19 professional relationships, and ethics.
- 20 (E) Supervised experiences--laboratory, practicum, or
- 21 internship.
- 22 (F) Evaluation--statistics and research methodology, follow-up
- 23 evaluation, and measurement methods.
- 24 (ii) Has successfully completed the department's guidance
- 25 counselor examination.
- 26 (iii) Has been recommended by an approved school counselor
- 27 education program to provide services as a school counselor.

- 1 (c) The individual meets both of the following:
- 2 (i) Has at least 5 years of successful experience serving in a
- 3 school counseling role in another state within the immediately
- 4 preceding 7-year period.
- 5 (ii) Has successfully completed the department's guidance
- 6 counselor examination.
- 7 (3) Except for teachers ENGAGED TO TEACH UNDER SECTION 1233B
- 8 AND TEACHERS engaged to teach in a community district under section
- 9 1233c, the intermediate superintendent shall notify the
- 10 superintendent of public instruction immediately of the names of
- 11 noncertificated teachers teaching in violation of subsection (1)
- 12 and the names of individuals serving in counseling roles in
- 13 violation of subsection (2), the employing district, and the amount
- 14 of time the noncertificated teachers or unqualified individuals
- 15 were employed.
- 16 (4) A vocational teacher preparation institution shall utilize
- 17 the employment experience of an annually authorized teacher for the
- 18 purpose of waiving student teaching as a requirement for vocational
- 19 certification if the annually authorized teacher is supervised by
- 20 the teacher preparation institution.
- 21 (5) All vocational education teachers certified after June 1,
- 22 1995 shall pass a competency test.
- 23 (6) The board of a school district or intermediate school
- 24 district may employ an individual without a teaching certificate as
- 25 a substitute teacher if the individual has at least 90 semester
- 26 hours of college credit from a college or university.
- 27 (7) Beginning 2 years after the effective date of the

- 1 amendatory act that added this subsection, FEBRUARY 6, 2020, the
- 2 department shall not renew an individual's school counselor
- 3 credential unless the department determines that, within the time
- 4 period since the individual's school counselor credential was
- 5 issued or last renewed, whichever is most recent, the individual
- 6 has completed at least 25 hours of professional development
- 7 approved by the department under subsection (9) covering counseling
- 8 about the college preparation and selection process and at least 25
- 9 hours of professional development approved by the department under
- 10 subsection (9) covering career counseling. For the purposes of this
- 11 subsection, career counseling includes, but is not limited to,
- 12 exploration of military career options and the skilled trades as
- 13 well as other careers and pathways that lead to industry
- 14 credentials awarded in recognition of an individual's attainment of
- 15 measurable technical or occupational skills necessary to obtain
- 16 employment or advance within an occupation. The hours of
- 17 professional development required under this subsection covering
- 18 career counseling shall include at least 5 hours covering military
- 19 career options. The hours of professional development required
- 20 under this subsection are a part of and not in addition to
- 21 professional development requirements under department rule.
- 22 (8) An individual may complete the professional development
- 23 hours for the purposes of subsection (7) as part of the
- 24 professional development provided by a school district,
- 25 intermediate school district, public school academy, or nonpublic
- 26 school under section 1527 if the content and curriculum of the
- 27 professional development provided under section 1527 are approved

- 1 by the department under subsection (9).
- 2 (9) The department shall approve the professional development
- 3 for the purposes of subsection (7). The department shall only
- 4 approve a professional development program or course for the
- 5 purposes of subsection (7) if the department determines that the
- 6 content and curriculum for the professional development meet
- 7 standards that are developed by the department in consultation with
- 8 the department of talent and economic development and groups
- 9 representing school counselors, college admissions professionals,
- 10 financial aid officers, employers, and others as determined
- 11 appropriate by the department. The department shall develop these
- 12 standards by July 1, 2018 and shall facilitate the involvement in
- 13 the development of the standards of the groups required under this
- 14 subsection.
- 15 (10) The superintendent of public instruction shall promulgate
- or modify rules as necessary to implement subsections (7) to (9).
- Sec. 1233b. (1) Except SUBJECT TO SUBSECTION (2) AND EXCEPT as
- 18 provided in subsection (3), the board of a local SCHOOL DISTRICT or
- 19 intermediate school district OR THE BOARD OF DIRECTORS OF A PUBLIC
- 20 SCHOOL ACADEMY may engage a full-time or part-time noncertificated,
- 21 nonendorsed teacher to teach a course in computer science, a
- 22 foreign language, mathematics, biology, chemistry, engineering,
- 23 physics, robotics, or in another subject area determined by the
- 24 state board to be appropriate to be included under this section and
- 25 so designated by the state board, or any combination of these
- 26 subject areas, in grades 9 through 12, OR IN A CAREER AND TECHNICAL
- 27 EDUCATION PROGRAM.

- 1 (2) Subject to subsection (3), a noncertificated, nonendorsed
- 2 teacher is qualified to teach pursuant to UNDER this section if he
- 3 or she meets all AT LEAST 1 of the following minimum requirements:
- 4 (A) BOTH OF THE FOLLOWING:
- 5 (i) POSSESSES AN EARNED DOCTORAL DEGREE FROM AN ACCREDITED
- 6 POSTSECONDARY INSTITUTION.
- 7 (ii) IS A FACULTY MEMBER EMPLOYED FULL-TIME BY AN ACCREDITED
- 8 POSTSECONDARY INSTITUTION WHO HAS BEEN GRANTED INSTITUTIONAL
- 9 TENURE, OR HAS BEEN DESIGNATED AS BEING ON TENURE TRACK, BY THE
- 10 POSTSECONDARY INSTITUTION.
- 11 (B) ALL OF THE FOLLOWING:
- 12 (i) $\frac{(a)}{(a)}$ Possesses an earned bachelor's degree from an
- 13 accredited postsecondary institution.
- 14 (ii) (b)—Has a major or a graduate degree in the field of
- 15 specialization in which he or she will teach.
- 16 (iii) (c)—If the teacher desires to teach for more than 1
- 17 year, has passed both a basic skills examination and a subject area
- 18 examination, if a subject area examination exists, in the field of
- 19 specialization in which he or she will teach.
- 20 (iv) (d) Except in the case of persons INDIVIDUALS engaged to
- 21 teach a foreign language, has, in the 5-year period immediately
- 22 preceding the date of hire, not less than 2 years of occupational
- 23 experience in the field of specialization in which he or she will
- 24 teach.
- 25 (C) FOR TEACHING IN A CAREER AND TECHNICAL EDUCATION PROGRAM,
- 26 HOLDS A PROFESSIONAL LICENSE OR CERTIFICATION ISSUED BY THIS STATE
- 27 IN THE SUBJECT MATTER IN WHICH HE OR SHE IS ENGAGED TO TEACH.

- 1 (D) HOLDS A CURRENT TEACHING CERTIFICATE OR LICENSE ISSUED BY
- 2 A DEPARTMENT, BOARD, OR AUTHORITY IN ANOTHER STATE OF THE UNITED
- 3 STATES OR THE DISTRICT OF COLUMBIA.
- 4 (3) The requirements listed in subsection (2) for a teacher
- 5 engaged to teach pursuant to UNDER this section shall be in
- 6 addition to any other requirements established by the board of a
- 7 local SCHOOL DISTRICT or intermediate school district OR THE BOARD
- 8 OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY, as applicable.
- 9 (4) Except as provided in subsection (5), the board of a local
- 10 SCHOOL DISTRICT or intermediate school district OR THE BOARD OF
- 11 DIRECTORS OF A PUBLIC SCHOOL ACADEMY shall not engage a full-time
- 12 or part-time noncertificated, nonendorsed teacher to teach a course
- 13 described in subsection (1) if the district OR PUBLIC SCHOOL
- 14 ACADEMY is able to engage a certificated, endorsed teacher.
- 15 (5) If the board of a local SCHOOL DISTRICT or intermediate
- 16 school district OR THE BOARD OF DIRECTORS OF A PUBLIC SCHOOL
- 17 ACADEMY is able to engage a certificated, endorsed teacher to teach
- 18 a course described in subsection (1), the local or intermediate
- 19 school—board OR BOARD OF DIRECTORS may employ or continue to employ
- 20 a noncertificated, nonendorsed teacher to teach the course if both
- 21 of the following conditions are met: THE NONCERTIFICATED,
- 22 NONENDORSED TEACHER MEETS AT LEAST 1 OF THE FOLLOWING:
- 23 (A) BOTH OF THE FOLLOWING:
- 24 (i) (a) The noncertificated, nonendorsed teacher is annually
- 25 and continually enrolled and completing credit in an approved
- 26 teacher preparation program leading to a provisional teaching
- 27 certificate.

- 1 (ii) (b)—The noncertificated, nonendorsed teacher has a
- 2 planned program leading to teacher certification on file with the
- 3 employing school district, or intermediate school district, OR
- 4 PUBLIC SCHOOL ACADEMY, his or her teacher preparation institution,
- 5 and the department. of education.
- 6 (B) FOR A NONCERTIFICATED, NONENDORSED TEACHER TEACHING IN A
- 7 CAREER AND TECHNICAL EDUCATION PROGRAM, MEETS BOTH OF THE
- 8 FOLLOWING:
- 9 (i) DURING THE FIRST 2 YEARS OF HIS OR HER EMPLOYMENT AS A
- 10 TEACHER UNDER THIS SECTION, COMPLETES A PROGRAM OF INSTRUCTION ON
- 11 PEDAGOGICAL SKILLS THAT IS APPROVED BY THE BOARD OF THE SCHOOL
- 12 DISTRICT OR INTERMEDIATE SCHOOL DISTRICT OR THE BOARD OF DIRECTORS
- 13 OF THE PUBLIC SCHOOL ACADEMY EMPLOYING THE TEACHER.
- 14 (ii) ENGAGES IN A COMPREHENSIVE AND ONGOING MENTORSHIP
- 15 EXPERIENCE, AS DETERMINED BY THE BOARD OF THE SCHOOL DISTRICT OR
- 16 INTERMEDIATE SCHOOL DISTRICT OR THE BOARD OF DIRECTORS OF THE
- 17 PUBLIC SCHOOL ACADEMY EMPLOYING THE TEACHER.
- 18 (6) If the—A noncertificated, nonendorsed teacher completes 3
- 19 years of successful classroom teaching, as determined by regular
- 20 observation and review by school district, INTERMEDIATE SCHOOL
- 21 DISTRICT, OR PUBLIC SCHOOL ACADEMY PERSONNEL and teacher
- 22 preparation institution personnel, the department of education and
- 23 a teacher preparation institution shall utilize the teaching
- 24 experience of a noncertificated, nonendorsed teacher for the
- 25 purpose of waiving student teaching as a condition for receiving a
- 26 continued employment authorization in the school district,
- 27 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY and a

- 1 provisional teaching certificate.
- 2 Sec. 1531i. (1) The superintendent of public instruction shall
- 3 establish a process for a person AN INDIVIDUAL to earn an interim
- 4 teaching certificate under this section that qualifies the person
- 5 INDIVIDUAL to teach in the public schools and to earn a Michigan
- 6 teaching certificate using the process under this section. The
- 7 process shall meet all applicable requirements for an alternative
- 8 teaching certification process under the no child left behind act
- 9 of 2001, Public Law 107-110. The process shall not allow for an
- 10 interim teaching certificate for special education.
- 11 (2) The process established under subsection (1) shall provide
- 12 that the superintendent of public instruction will grant an interim
- 13 teaching certificate to a person AN INDIVIDUAL who meets all of the
- 14 following:
- 15 (a) Is a participant in an alternative teaching program that
- 16 is approved by the superintendent of public instruction. To be
- 17 approved, a program provider shall demonstrate to the satisfaction
- 18 of the superintendent of public instruction that it meets all of
- 19 the following:
- 20 (i) Provides for its participants an intensive training
- 21 program in teaching that is determined by the superintendent of
- 22 public instruction to constitute the equivalent of at least 12
- 23 college credit hours and that includes training in at least all of
- 24 the following subject areas:
- 25 (A) Child development or child psychology.
- 26 (B) Family and community relationships.
- 27 (C) Diverse learners.

- 1 (D) Instructional strategies.
- 2 (E) A form of field-based experience in a classroom setting.
- 3 (ii) Has a proven record of producing successful teachers in 1
- 4 or more other states or is modeled after a program that has a
- 5 proven record of producing successful teachers in 1 or more other
- 6 states.
- 7 (iii) Accepts for participation only persons INDIVIDUALS who
- 8 meet the requirements of subdivision (b).
- 9 (b) Holds a bachelor's, master's, doctorate, or professional
- 10 degree from a regionally accredited college or university with a
- 11 grade point average of at least 3.0 on a 4.0 scale or the
- 12 equivalent on another scale, as determined by the superintendent of
- 13 public instruction.
- 14 (c) Passes both the basic skills examination and the
- 15 appropriate available subject area examination for each subject
- 16 area in which he or she applies to be certified.
- 17 (3) THE PROCESS ESTABLISHED UNDER SUBSECTION (1) SHALL PROVIDE
- 18 THAT THE SUPERINTENDENT OF PUBLIC INSTRUCTION WILL GRANT AN INTERIM
- 19 TEACHING CERTIFICATE TO A TEACHER WHO HAS TAUGHT UNDER SECTION
- 20 1233B FOR 3 YEARS.
- 21 (4) (3) A person AN INDIVIDUAL earning a provisional
- 22 certificate under this section will be subject to provisions of
- 23 administrative rules governing teachers, as established by the
- 24 superintendent of public instruction.
- 25 (5) (4) A person AN INDIVIDUAL who possesses an interim
- 26 teaching certificate under this section may be employed to teach in
- 27 a public school in the same manner as a person AN INDIVIDUAL

- 1 holding a Michigan teaching certificate issued under section 1531
- 2 if all of the following requirements are met:
- 3 (a) While the person INDIVIDUAL is teaching under an interim
- 4 teaching certificate, the school district or public school academy
- 5 in which the person-INDIVIDUAL is teaching provides intensive
- 6 observation and coaching in a manner and to the extent prescribed
- 7 by the superintendent of public instruction.
- 8 (b) The person INDIVIDUAL is making satisfactory progress
- 9 toward meeting the requirements for being awarded a Michigan
- 10 teaching certificate under section 1531, as established by the
- 11 superintendent of public instruction under subsection (5). (6).
- 12 (6) (5)—The superintendent of public instruction shall develop
- 13 standards for granting a person AN INDIVIDUAL a Michigan teaching
- 14 certificate issued under section 1531 after the person INDIVIDUAL
- 15 has demonstrated satisfactory teaching performance for 3 years
- 16 under an interim teaching certificate and has met the requirements
- 17 established by the superintendent of public instruction for a
- 18 Michigan teaching certificate.
- 19 (7) (6)—The superintendent of public instruction shall
- 20 promulgate rules that he or she considers necessary to implement
- 21 this section.
- 22 (8) (7) As used in this section, "basic skills examination",
- 23 "elementary certification examination" —and "subject area
- 24 examination" mean those terms as defined in section 1531.
- 25 Enacting section 1. This amendatory act takes effect 90 days
- 26 after the date it is enacted into law.
- 27 Enacting section 2. This amendatory act does not take effect

- 1 unless Senate Bill No. 910
- of the 99th Legislature is enacted into law.
