## **SENATE BILL No. 1039**

May 30, 2018, Introduced by Senators HANSEN, MACGREGOR and STAMAS and referred to the Committee on Oversight.

A bill to amend 1939 PA 280, entitled "The social welfare act,"

(MCL 400.1 to 400.119b) by adding section 105q.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 105G. (1) FOR AN INDIVIDUAL IN A NURSING FACILITY
- 2 APPLYING FOR MEDICAL ASSISTANCE UNDER THIS ACT, IF THE DEPARTMENT
- 3 HAS NOT COMPLETED ITS ELIGIBILITY DETERMINATION WITHIN 45 DAYS OF
- 4 RECEIVING A COMPLETED APPLICATION, THAT INDIVIDUAL SHALL BE
- 5 AFFORDED PRESUMPTIVE ELIGIBILITY IN THE MEDICAL ASSISTANCE PROGRAM.
- (2) WHEN THE DEPARTMENT PERFORMS AN ELIGIBILITY
- 7 REDETERMINATION FOR A MEDICAL ASSISTANCE RECIPIENT WHO HAS RESIDED
- 8 IN A NURSING FACILITY FOR AT LEAST 180 DAYS IN THE PAST 12 MONTHS,
- 9 THE DEPARTMENT SHALL ALLOW THE RECIPIENT OR HIS OR HER

- 1 REPRESENTATIVE TO ATTEST TO ANY CHANGE IN ASSETS OR INCOME TO
- 2 PROVIDE AN ACCELERATED REDETERMINATION PROCESS.
- 3 (3) WHEN THE DEPARTMENT DETERMINES THAT A DIVESTMENT PENALTY
- 4 PERIOD IS APPROPRIATE FOR A RECIPIENT RESIDING IN A NURSING
- 5 FACILITY, IF THE NURSING FACILITY WAS NOT AWARE OF THE DIVESTMENT
- 6 PENALTY, THE DEPARTMENT SHALL CONTINUE TO PAY THE NURSING FACILITY
- 7 THE FULL MEDICAID PER DIEM RATE DURING THE DIVESTMENT PENALTY
- 8 PERIOD AND SHALL COLLECT THE MONEY PAID DURING THE DIVESTMENT
- 9 PENALTY PERIOD DIRECTLY FROM THE RECIPIENT.
- 10 (4) THE DEPARTMENT SHALL MAKE AVAILABLE AN OUTSTATION WORKER
- 11 TO UTILIZE TO FACILITATE MEDICAID ELIGIBILITY DETERMINATION TO A
- 12 NURSING FACILITY THAT REQUESTS AN OUTSTATION WORKER.
- 13 (5) IF A RECIPIENT RESIDING IN A NURSING FACILITY HAS A COURT-
- 14 ORDERED PAYMENT OR GARNISHMENT, THE DEPARTMENT MUST AUTOMATICALLY
- 15 APPLY THE COURT-ORDERED PAYMENT OR GARNISHMENT BEFORE DETERMINING
- 16 THE PATIENT-PAY AMOUNT.
- 17 (6) THE DEPARTMENT SHALL HOLD A NURSING FACILITY HARMLESS FOR
- 18 RESOURCES HELD IN A TRUST SOLELY FOR THE BENEFIT OF THE RECIPIENT'S
- 19 SPOUSE IF THE NURSING FACILITY WAS UNAWARE OF THE SOLELY FOR THE
- 20 BENEFIT TRUST.
- 21 Enacting section 1. This amendatory act takes effect 90 days
- 22 after the date it is enacted into law.
