It is pretty clear that through John's work here, in his 33 years, we will be experiencing, and the rest of the state of Michigan will be experiencing, the impact of his work for many years to come. His strong leadership has helped to build one of the best law firms in Lansing that strictly serves the Legislature. My only regret, in my short tenure, is that I have never had the privilege to work directly with John on a project, but his reputation precedes him well.

We wish John and his wife, Karen, and their beloved family—they are all in the Gallery today—the happiest of retirements. John, thank you for your service. In recognition of that, we have this Tribute for you as well. Congratulations and good luck, John.
