A bill to amend 1953 PA 232, entitled "Corrections code of 1953,"

by amending sections 33 and 34 (MCL 791.233 and 791.234), section 33 as amended by 2017 PA 14 and section 34 as amended by 2017 PA 265.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 33. (1) The grant of a parole is subject to all of the 2 following conditions:
- 3 (a) A prisoner must not be given liberty on parole until the4 board has reasonable assurance, after consideration of all of the

- facts and circumstances, including the prisoner's mental and social
 attitude, that the prisoner will not become a menace to society or
 to the public safety.
- 4 (b) Except as provided in section 34a and section 35(10), a 5 parole must not be granted to a prisoner other than a prisoner 6 subject to disciplinary time until the prisoner has served the 7 minimum term imposed by the court less allowances for good time or 8 special good time to which the prisoner may be entitled by statute, 9 except that a prisoner other than a prisoner subject to 10 disciplinary time is eligible for parole before the expiration of 11 his or her minimum term of imprisonment whenever if the sentencing judge, or the judge's successor in office, gives written approval 12 13 of the parole of the prisoner before the expiration of the minimum 14 term of imprisonment.

- (c) Except as provided in section 34a and section 35(10), and notwithstanding the provisions of subdivision (b), a parole must not be granted to a prisoner other than a prisoner subject to disciplinary time sentenced for the commission of a crime described in section 33b(a) to (cc) until the prisoner has served the minimum term imposed by the court less an allowance for disciplinary credits as provided in section 33(5) of 1893 PA 118, MCL 800.33. A prisoner described in this subdivision is not eligible for special parole.
- (d) Except as provided in section 34a and section 35(10), a parole must not be granted to a prisoner subject to disciplinary time until the prisoner has served the minimum term imposed by the court.
- (e) A prisoner must not be released on parole until the paroleboard has satisfactory evidence that arrangements have been made

- 1 for such honorable and useful employment as the prisoner is capable
- 2 of performing, for the prisoner's education, or for the prisoner's
- 3 care if the prisoner is mentally or physically ill or
- 4 incapacitated.
- 5 (f) A-Except as provided in section 35(10), a prisoner whose

- 8 diploma or a high school equivalency certificate. The director of
- 9 the department may waive the restriction imposed by this

- 12 which he or she was incarcerated. The department may also waive the

- (3) The parole board may promulgate rules under the administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328, that are not inconsistent with this act with respect to conditions imposed upon prisoners paroled under this act.
- Sec. 34. (1) Except for a prisoner granted parole under section 35(10) or as provided in section 34a, a prisoner sentenced to an indeterminate sentence and confined in a state correctional facility with a minimum in terms of years other than a prisoner subject to disciplinary time is subject to the jurisdiction of the parole board when the prisoner has served a period of time equal to the minimum sentence imposed by the court for the crime of which he or she was convicted, less good time and disciplinary credits, if applicable.
- (2) Except for a prisoner granted parole under section 35(10) or as provided in section 34a, a prisoner subject to disciplinary time sentenced to an indeterminate sentence and confined in a state correctional facility with a minimum in terms of years is subject to the jurisdiction of the parole board when the prisoner has served a period of time equal to the minimum sentence imposed by the court for the crime of which he or she was convicted.
- (3) If Except for a prisoner granted parole under section 35(10), if a prisoner other than a prisoner subject to disciplinary time is sentenced for consecutive terms, whether received at the same time or at any time during the life of the original sentence, the parole board has jurisdiction over the prisoner for purposes of parole when the prisoner has served the total time of the added minimum terms, less the good time and disciplinary credits allowed

- 2 compute the new maximum term under this subsection, and discharge
- 3 must be issued only after the total of the maximum sentences has

- (a) At the conclusion of 10 calendar years of the prisoner's sentence and thereafter as determined by the parole board until the prisoner is paroled, discharged, or deceased, and in accordance with the procedures described in subsection (9), (10), 1 member of the parole board shall interview the prisoner. The interview schedule prescribed in this subdivision applies to all prisoners to whom subsection (7)—(8) applies, regardless of the date on which they were sentenced.
- (b) In addition to the interview schedule prescribed in subdivision (a), the parole board shall review the prisoner's file at the conclusion of 15 calendar years of the prisoner's sentence and every 5 years thereafter until the prisoner is paroled, discharged, or deceased. A prisoner whose file is to be reviewed under this subdivision shall must be notified of the upcoming file review at least 30 days before the file review takes place and must

be allowed to submit written statements or documentary evidence forthe parole board's consideration in conducting the file review.

3 (c) A decision to grant or deny parole to the prisoner must not be made until after a public hearing held in the manner 4 prescribed for pardons and commutations in sections 44 and 45. 5 6 Notice of the public hearing must be given to the sentencing judge, 7 or the judge's successor in office. Parole must not be granted if 8 the sentencing judge files written objections to the granting of 9 the parole within 30 days of receipt of the notice of hearing, but 10 the sentencing judge's written objections bar the granting of 11 parole only if the sentencing judge is still in office in the court before which the prisoner was convicted and sentenced. A sentencing 12 judge's successor in office may file written objections to the 13 14 granting of parole, but a successor judge's objections must not bar 15 the granting of parole under subsection (7). (8). If written objections are filed by either the sentencing judge or the judge's 16 17 successor in office, they the objections must be made part of the 18 prisoner's file.

(d) A parole granted under subsection (7)—(8) must be for a period of not less than 4 years and subject to the usual rules pertaining to paroles granted by the parole board. A parole granted under subsection (7)—(8) is not valid until the transcript of the record is filed with the attorney general whose certification of receipt of the transcript must be returned to the office of the parole board within 5 days. Except for medical records protected under section 2157 of the revised judicature act of 1961, 1961 PA 236, MCL 600.2157, the file of a prisoner granted a parole under subsection (7)—(8) is a public record.

 4 public health code, 1978 PA 368, MCL 333.7401 and 333.7403, and
 5 whether the violation for which the individual was convicted was
 6 committed to further the interests of that entity.
- 7 (iii) Whether the violation was committed in a drug-free school 2 one.
