A bill to create a request process for the gubernatorial removal of certain elected officials; and to prescribe the powers and duties of certain state officers.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Political subdivision" means a county, city, village,
- 3 township, charter township, or school district of this state.
- 4 (b) "School district" means a school district, a local school

- 4 Sec. 2. (1) An individual who is a resident of this state may
- 5 request that the governor remove or suspend from office for gross
- 6 neglect of duty or for corrupt conduct in office, or for any other
- 7 misfeasance or malfeasance in office, an elected officer of a
- 8 political subdivision. A request made under this subsection must
- 9 meet all of the following requirements:
- 10 (a) Be in writing.
- 11 (b) Be submitted to the governor.
- 12 (c) Specify the charges of gross neglect of duty or corrupt
