

HOUSE BILL NO. 4270

February 28, 2019, Introduced by Reps. Griffin, Paquette, O'Malley and Howell and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code," by amending sections 1278a and 1278b (MCL 380.1278a and 380.1278b), section 1278a as amended by 2018 PA 232 and section 1278b as amended by 2018 PA 230.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1278a. (1) Except as otherwise provided in this section
- 2 or section 1278b, beginning with pupils entering grade 8 in 2006,
- 3 the board of a school district or board of directors of a public



1 school academy shall not award a high school diploma to a pupil
2 unless the pupil meets all of the following:

3 (a) Has successfully completed all of the following credit
4 requirements of the Michigan merit standard before graduating from
5 high school:

6 (i) At least 4 credits in mathematics that are aligned with
7 subject area content expectations developed by the department and
8 approved by the state board under section 1278b, including
9 completion of at least algebra I, geometry, and algebra II, or an
10 integrated sequence of this course content that consists of 3
11 credits, and an additional mathematics credit, such as
12 trigonometry, statistics, precalculus, calculus, applied math,
13 accounting, business math, a retake of algebra II, or a course in
14 financial literacy as described in section 1165. A pupil may
15 complete algebra II over 2 years with 2 credits awarded or over 1.5
16 years with 1.5 credits awarded for the purposes of this section and
17 section 1278b. A pupil also may partially or fully fulfill the
18 algebra II requirement by completing a department-approved formal
19 career and technical education program or curriculum, such as a
20 program or curriculum in electronics, machining, construction,
21 welding, engineering, computer science, or renewable energy, and in
22 that program or curriculum successfully completing the same content
23 as the algebra II benchmarks assessed on the department-prescribed
24 state high school assessment, as determined by the department. The
25 department shall post on its website guidelines for implementation
26 of the immediately preceding sentence. Each pupil must successfully
27 complete at least 1 mathematics course during his or her final year
28 of high school enrollment. This subparagraph does not require
29 completion of mathematics courses in any particular sequence.



1 (ii) At least 3 credits in social science that are aligned with
 2 subject area content expectations developed by the department and
 3 approved by the state board under section 1278b, including
 4 completion of at least 1 credit in United States history and
 5 geography, 1 credit in world history and geography, 1/2 credit in
 6 economics, and the civics course described in section 1166(2). The
 7 1/2-credit economics requirement may be satisfied by completion of
 8 at least a 1/2-credit course in personal economics that includes a
 9 financial literacy component as described in section 1165, if that
 10 course covers the subject area content expectations for economics
 11 developed by the department and approved by the state board under
 12 section 1278b.

13 (iii) At least 1 credit in subject matter that includes both
 14 health and physical education aligned with guidelines developed by
 15 the department and approved by the state board under section 1278b,
 16 or at least 1/2 credit in health aligned with guidelines developed
 17 by the department and approved by the state board under section
 18 1278b and at least 1/2 credit awarded by the school district or
 19 public school academy for approved participation in extracurricular
 20 athletics or other extracurricular activities involving physical
 21 activity.

22 (iv) At least ~~1 credit in visual arts, performing arts, or~~
 23 ~~applied arts, as defined by the department, that is~~ **3 credits in**
 24 **21st century skills described in section 1278f**, aligned with
 25 guidelines developed by the department and approved by the state
 26 board under section 1278b. ~~A school district or public school~~
 27 ~~academy is strongly encouraged to offer visual arts and performing~~
 28 ~~arts courses.~~

29 (v) The credit requirements specified in section 1278b(1).



1 (b) Meets the online course or learning experience requirement
2 of this subsection. A school district or public school academy
3 shall provide the basic level of technology and internet access
4 required by the state board to complete the online course or
5 learning experience. For a pupil to meet this requirement, the
6 pupil shall meet either of the following, as determined by the
7 school district or public school academy:

8 (i) Has successfully completed at least 1 course or learning
9 experience that is presented online, as defined by the department.

10 (ii) The pupil's school district or public school academy has
11 integrated an online experience throughout the high school
12 curriculum by ensuring that each teacher of each course that
13 provides the required credits of the Michigan merit curriculum has
14 integrated an online experience into the course.

15 ~~(2) In addition to the requirements under subsection (1),~~
16 ~~beginning with pupils entering grade 3 in 2006, the board of a~~
17 ~~school district or board of directors of a public school academy~~
18 ~~shall not award a high school diploma to a pupil unless the pupil~~
19 ~~has successfully completed during grades K to 12 at least 2 credits~~
20 ~~that are grade-appropriate in a language other than English or~~
21 ~~course work or other learning experiences that are substantially~~
22 ~~equivalent to 2 credits in a language other than English, based on~~
23 ~~guidelines developed by the department. For pupils who graduate~~
24 ~~from high school in 2016, 2017, 2018, 2019, 2020, 2021, 2022, 2023,~~
25 ~~or 2024 only, a pupil may partially or fully fulfill 1 credit of~~
26 ~~this requirement by completing a department-approved formal career~~
27 ~~and technical education program or curriculum or by completing~~
28 ~~visual or performing arts instruction that is in addition to the~~
29 ~~requirements under subsection (1) (a) (iv).~~ The board of a school



1 district or board of directors of a public school academy is
 2 strongly encouraged to ensure that all pupils complete at least 1
 3 credit in a language other than English, **as described in section**
 4 **1278f**, in grades K to 6. ~~For the purposes of this subsection, all~~
 5 ~~of the following apply:~~

6 ~~(a) American sign language is considered to be a language~~
 7 ~~other than English.~~

8 ~~(b) The pupil may meet all or part of this requirement with~~
 9 ~~online course work.~~

10 ~~(c) Not later than September 1, 2018, and not later than~~
 11 ~~September 1 of each subsequent school year, a school district or~~
 12 ~~public school academy shall report to the department both of the~~
 13 ~~following, in a form and manner prescribed by the department:~~

14 ~~(i) The number of pupils who partially or fully fulfilled 1~~
 15 ~~credit in a language other than English by completing a department-~~
 16 ~~approved formal career and technical education program or~~
 17 ~~curriculum under this subsection in the immediately preceding~~

19 ~~(ii) The number of pupils who partially or fully fulfilled 1~~

24 (3) The requirements under this section and section 1278b for
 25 a high school diploma are in addition to any local requirements
 26 imposed by the board of a school district or board of directors of
 27 a public school academy. The board of a school district or board of
 28 directors of a public school academy, as a local requirement for a
 29 high school diploma, may require a pupil to complete the Michigan



1 merit examination under section 1279g or may require a pupil to
2 participate in the MIAccess assessments if appropriate for the
3 pupil.

4 (4) For the purposes of this section and section 1278b, all of
5 the following apply:

6 (a) A pupil is considered to have completed a credit if the
7 pupil successfully completes the subject area content expectations
8 or guidelines developed by the department that apply to the credit.
9 For a career and technical education credit, a school district or
10 public school academy may supplement those content expectations and
11 guidelines with additional guidelines developed by the school
12 district or public school academy.

13 (b) A school district or public school academy shall base its
14 determination of whether a pupil has successfully completed the
15 subject area content expectations or guidelines developed by the
16 department that apply to a credit at least in part on the pupil's
17 performance on the assessments developed or selected by the
18 department under section 1278b or on 1 or more assessments
19 developed or selected by the school district or public school
20 academy that measure a pupil's understanding of the subject area
21 content expectations or guidelines that apply to the credit.

22 (c) A school district or public school academy shall also
23 grant a pupil a credit if the pupil earns a qualifying score, as
24 determined by the department, on the assessments developed or
25 selected for the subject area by the department under section 1278b
26 or the pupil earns a qualifying score, as determined by the school
27 district or public school academy, on 1 or more assessments
28 developed or selected by the school district or public school
29 academy that measure a pupil's understanding of the subject area



1 content expectations or guidelines that apply to the credit.

2 (5) If a high school is designated by the superintendent of
3 public instruction as a specialty school and the high school meets
4 the requirements of subsection (6), then the pupils of the high
5 school are not required to successfully complete the 4 credits in
6 English language arts required under section 1278b(1)(a) or the 3
7 credits in social science required under subsection (1)(a)(ii) and
8 the school district or public school academy is not required to
9 ensure that each pupil is offered the curriculum necessary for
10 meeting those English language arts or social science credit
11 requirements. The superintendent of public instruction may
12 designate up to 15 high schools that meet the requirements of this
13 subsection as specialty schools. Subject to this maximum number,
14 the superintendent of public instruction shall designate a high
15 school as a specialty school if the superintendent of public
16 instruction finds that the high school meets all of the following
17 criteria:

18 (a) The high school incorporates a significant reading and
19 writing component throughout its curriculum.

20 (b) The high school uses a specialized, innovative, and
21 rigorous curriculum in such areas as performing arts, foreign
22 language, extensive use of internships, or other learning
23 innovations that conform to pioneering innovations among other
24 leading national or international high schools.

25 (6) A high school that is designated by the superintendent of
26 public instruction as a specialty school under subsection (5) is
27 only exempt from requirements as described under subsection (5) as
28 long as the superintendent of public instruction finds that the
29 high school continues to meet all of the following requirements:



1 (a) The high school clearly states to prospective pupils and
2 their parents that it does not meet the requirements of the
3 Michigan merit standard under this section and section 1278b but is
4 a designated specialty school that is exempt from some of those
5 requirements and that a pupil who enrolls in the high school and
6 subsequently transfers to a high school that is not a specialty
7 school meeting the requirements of this subsection will be required
8 to comply with the requirements of the Michigan merit standard
9 under this section and section 1278b.

10 (b) For the most recent year for which the data are available,
11 the mean scores on both the mathematics ~~and science portions of the~~
12 ~~ACT examination~~ **portion of the SAT examination and the science**
13 **portion of the applicable state assessment** for the pupils of the
14 high school exceed by at least 10% the mean scores on the
15 mathematics ~~and science portions of the ACT examination~~ **portion of**
16 **the SAT examination and the science portion of the applicable state**
17 **assessment** for the pupils of the school district in which the
18 greatest number of the pupils of the high school reside.

19 (c) For the most recent year for which the data are available,
20 the high school had a graduation rate of at least 85%, as
21 determined by the department.

22 (d) For the most recent year for which the data are available,
23 at least 75% of the pupils who graduated from the high school the
24 preceding year are enrolled in a postsecondary institution.

25 (e) All pupils of the high school are required to meet the
26 mathematics credit requirements of subsection (1) (a) (i), with no
27 modification of these requirements under section 1278b(5), and each
28 pupil is offered the curriculum necessary to meet this requirement.

29 (f) All pupils of the high school are required to meet the



1 science credit requirements of section 1278b(1) (b) and are also
2 required to successfully complete at least 1 additional science
3 credit, for a total of at least 4 science credits, with no
4 modification of these requirements under section 1278b(5), and each
5 pupil is offered the curriculum necessary to meet this requirement.

6 Sec. 1278b. (1) Except as otherwise provided in this section
7 or section 1278a, beginning with pupils entering grade 8 in 2006,
8 as part of the requirements under section 1278a the board of a
9 school district or board of directors of a public school academy
10 shall not award a high school diploma to a pupil unless the pupil
11 has successfully completed all of the following credit requirements
12 of the Michigan merit standard before graduating from high school:

13 (a) At least 4 credits in English language arts that are
14 aligned with subject area content expectations developed by the
15 department and approved by the state board under this section.

16 (b) At least 3 credits in science that are aligned with
17 subject area content expectations developed by the department and
18 approved by the state board under this section, including
19 completion of at least biology and either chemistry, physics,
20 anatomy, or agricultural science, or successfully completing a
21 program or curriculum that provides the same content as the
22 chemistry or physics benchmarks, as determined by the department. A
23 student may fulfill the requirement for the third science credit by
24 completing a department-approved computer science program or
25 curriculum or formal career and technical education program or
26 curriculum. The legislature strongly encourages pupils to complete
27 a fourth credit in science, such as forensics, astronomy, Earth
28 science, agricultural science, environmental science, geology,
29 physics, chemistry, physiology, or microbiology.



1 (c) The credit requirements specified in section 1278a(1) (a) (i)
2 to (iv).

3 (2) If a pupil successfully completes 1 or more of the high
4 school credits required under subsection (1) or under section
5 1278a(1) before entering high school, the pupil shall be given high
6 school credit for that credit.

7 (3) For the purposes of this section and section 1278a, the
8 department shall do all of the following:

9 (a) Develop subject area content expectations that apply to
10 the credit requirements of the Michigan merit standard that are
11 required under subsection (1) (a) and (b) and section 1278a(1) (a) (i)
12 and (ii) and develop guidelines for the remaining credit
13 requirements of the Michigan merit standard that are required under
14 this section and section 1278a(1) (a) ~~and~~ for the online course or
15 learning experience required under section 1278a(1) (b). ~~and for~~
16 ~~the requirements for a language other than English under section~~
17 ~~1278a(2).~~ All of the following apply to these subject area content
18 expectations and guidelines:

19 (i) All subject area content expectations ~~shall~~**must** be
20 consistent with the state board recommended model core academic
21 curriculum content standards under section 1278. Subject area
22 content expectations or guidelines ~~shall~~**must** not include
23 attitudes, beliefs, or value systems that are not essential in the
24 legal, economic, and social structure of our society and to the
25 personal and social responsibility of citizens of our society. The
26 subject area content expectations ~~shall~~**must** require pupils to
27 demonstrate critical thinking skills.

28 (ii) The subject area content expectations and the guidelines
29 must be approved by the state board under subsection (4).



1 (iii) The subject area content expectations ~~shall~~**must** state in
2 clear and measurable terms what pupils are expected to know upon
3 completion of each credit.

4 (iv) The department shall complete the development of the
5 subject area content expectations that apply to algebra I and the
6 guidelines for the online course or learning experience under
7 section 1278a(1) (b) not later than August 1, 2006.

8 (v) The department shall complete development of the subject
9 area content expectations or guidelines that apply to each of the
10 other credits required in the Michigan merit standard under
11 subsection (1) ~~and section 1278a(1) (a)~~ not later than 1 year before
12 the beginning of the school year in which a pupil entering high
13 school in 2007 would normally be expected to complete the credit.

14 (vi) If the department has not completed development of the
15 subject area content expectations that apply to a particular credit
16 required in the Michigan merit standard under subsection (1) ~~or~~
17 ~~section 1278a(1) (a)~~ by the date required under this subdivision, a
18 school district or public school academy may align the content of
19 the credit with locally adopted standards.

20 (vii) Until all of the subject area content expectations and
21 guidelines have been developed by the department and approved by
22 the state board, the department shall submit a report at least
23 every 6 months to the senate and house standing committees
24 responsible for education legislation on the status of the
25 development of the subject area content expectations and
26 guidelines. The report ~~shall~~**must** detail any failure by the
27 department to meet a deadline established under subparagraph (iv) or
28 (v) and the reasons for that failure.

29 (b) Develop and implement a process for developing the subject



1 area content expectations and guidelines required under this
2 section. This process ~~shall~~**must** provide for all of the following:

3 (i) Soliciting input from all of the following groups:

4 (A) Recognized experts in the relevant subject areas.

5 (B) Representatives from 4-year colleges or universities,
6 community colleges, and other postsecondary institutions.

7 (C) Teachers, administrators, and school personnel who have
8 specialized knowledge of the subject area.

9 (D) Representatives from the business community.

10 (E) Representatives from vocational and career and technical
11 education providers.

12 (F) Government officials, including officials from the
13 legislature.

14 (G) Parents of public school pupils.

15 (ii) A review of the subject area content expectations or
16 guidelines by national experts.

17 (iii) An opportunity for the public to review and provide input
18 on the proposed subject area content expectations or guidelines
19 before they are submitted to the state board for approval. The time
20 period allowed for this review and input ~~shall~~**must** be at least 15
21 business days.

22 (c) Determine the basic level of technology and internet
23 access required for pupils to complete the online course or
24 learning experience requirement of section 1278a(1)(b), and submit
25 that determination to the state board for approval.

26 (d) Develop and make available material to assist school
27 districts and public school academies in implementing the
28 requirements of this section and section 1278a. This shall include
29 developing guidelines for alternative instructional delivery



1 methods as described in subsection (7).

2 (4) The state board shall approve subject area content
3 expectations and guidelines developed by the department under
4 subsection (3) before those subject area content expectations and
5 guidelines may take effect. The state board also shall approve the
6 basic level of technology and internet access required for pupils
7 to complete the online course or learning experience requirement of
8 section 1278a(1)(b).

9 (5) The parent or legal guardian of a pupil who has completed
10 grade 9, a teacher who is currently teaching the pupil, who
11 currently teaches in or whose expertise is in a subject area
12 proposed to be modified by the personal curriculum, or who is
13 determined by the principal to have qualifications otherwise
14 relevant to developing a personal curriculum, or a school counselor
15 or school employee qualified to act in a counseling role under
16 section 1233 or 1233a may request a personal curriculum under this
17 subsection for the pupil that modifies certain of the Michigan
18 merit standard requirements under subsection (1) or section
19 1278a(1)(a). If the request for a personal curriculum is made by
20 the pupil's parent or legal guardian or, if the pupil is at least
21 age 18 or is an emancipated minor, by the pupil, the school
22 district or public school academy shall develop a personal
23 curriculum for the pupil. A teacher, school counselor, or school
24 employee qualified to act in a counseling role under section 1233
25 or 1233a may contact a pupil's parent or legal guardian to discuss
26 the possibility and potential benefits of a personal curriculum
27 under this subsection for the pupil. If all of the requirements
28 under this subsection for completing a personal curriculum are met,
29 then the board of a school district or board of directors of a



1 public school academy may award a high school diploma to a pupil
2 who successfully completes his or her personal curriculum even if
3 it does not meet the requirements of the Michigan merit standard
4 required under subsection (1) and section 1278a(1)(a). All of the
5 following apply to a personal curriculum:

6 (a) The personal curriculum shall be developed by a group that
7 includes at least the pupil, at least 1 of the pupil's parents or
8 the pupil's legal guardian, and a teacher described in this
9 subdivision or the pupil's high school counselor or another
10 designee qualified to act in a counseling role under section 1233
11 or 1233a selected by the high school principal. In addition, for a
12 pupil who receives special education services, a school
13 psychologist should also be included in this group. The teacher
14 included in the group developing the personal curriculum shall be a
15 teacher who is currently teaching the pupil, who currently teaches
16 in or whose expertise is in a subject area being modified by the
17 personal curriculum, or who is determined by the principal to have
18 qualifications otherwise relevant to the group. This subdivision
19 does not require an in-person meeting of the group.

20 (b) The personal curriculum ~~shall~~**must** incorporate as much of
21 the subject area content expectations of the Michigan merit
22 standard required under subsection (1) and section 1278a(1)(a) as
23 is practicable for the pupil; ~~shall~~**must** establish measurable goals
24 that the pupil must achieve while enrolled in high school and ~~shall~~
25 **must** provide a method to evaluate whether the pupil achieved these
26 goals; and ~~shall~~**must** be aligned with the pupil's educational
27 development plan developed under subsection (11).

28 (c) Before it takes effect, the personal curriculum must be
29 agreed to by the pupil's parent or legal guardian and by the



1 superintendent of the school district or chief executive of the
2 public school academy or his or her designee.

3 (d) The pupil's parent or legal guardian shall be in
4 communication with each of the pupil's teachers to monitor the
5 pupil's progress toward the goals contained in the pupil's personal
6 curriculum.

7 (e) Revisions may be made in the personal curriculum if the
8 revisions are developed and agreed to in the same manner as the
9 original personal curriculum.

10 (f) The English language arts credit requirements of
11 subsection (1)(a) and the science credit requirements of subsection
12 (1)(b) are not subject to modification as part of a personal
13 curriculum under this subsection.

14 (g) The mathematics credit requirements of section
15 1278a(1)(a)(i) may be modified as part of a personal curriculum if
16 the pupil successfully completes at least 3-1/2 total credits of
17 the mathematics credits required under that section before
18 completing high school, including algebra I and geometry, and
19 successfully completes at least 1 mathematics credit during his or
20 her final 2 years of high school. The algebra II credit required
21 under that section may be modified as part of a personal curriculum
22 under this subsection if the pupil meets 1 or more of the
23 following:

24 (i) Successfully completes the same content as 1 semester of
25 algebra II, as determined by the department.

26 (ii) Elects to complete the same content as algebra II over 2
27 years, with a credit awarded for each of those 2 years, and
28 successfully completes that content.

29 (iii) Enrolls in a formal career and technical education program



1 or curriculum and in that program or curriculum successfully
2 completes the same content as the algebra II benchmarks assessed on
3 the department-prescribed state high school assessment, as
4 determined by the department.

5 (iv) Successfully completes 1 semester of statistics, functions
6 and data analysis, or technical mathematics.

7 (h) The social science credit requirements of section
8 1278a(1) (a) (ii) may be modified as part of a personal curriculum
9 only if all of the following are met:

10 (i) The pupil has successfully completed 2 credits of the
11 social science credits required under section 1278a(1), including
12 the civics course described in section 1166(2).

13 (ii) The modification requires the pupil to complete 1
14 additional credit in English language arts, mathematics, or science
15 or 1 additional credit in a language other than English, or
16 requires the pupil to complete a formal career and technical
17 education program. This additional credit must be in addition to
18 the number of those credits otherwise required under subsection (1)
19 and section 1278a(1). ~~or under section 1278a(2).~~

20 (i) The health and physical education credit requirement under
21 section 1278a(1) (a) (iii) may be modified as part of a personal
22 curriculum only if the modification requires the pupil to complete
23 1 additional credit in English language arts, mathematics, or
24 science or 1 additional credit in a language other than English, or
25 requires the pupil to complete a formal career and technical
26 education program. This additional credit must be in addition to
27 the number of those credits otherwise required under subsection (1)
28 and section 1278a(1). ~~or under section 1278a(2).~~

29 (j) The ~~visual arts, performing arts, or applied arts~~ **21st**



1 **century skills** credit requirement under section 1278a(1) (a) (iv) may
2 be modified as part of a personal curriculum only if the
3 modification requires the pupil to complete 1 additional credit in
4 English language arts, mathematics, or science or 1 additional
5 credit in a language other than English, or requires the pupil to
6 complete a formal career and technical education program. This
7 additional credit must be in addition to the number of those
8 credits otherwise required under subsection (1) and section
9 1278a(1). ~~or under section 1278a(2).~~

10 (k) If the parent or legal guardian of a pupil requests as
11 part of the pupil's personal curriculum a modification of the
12 Michigan merit standard requirements that would not otherwise be
13 allowed under this section and demonstrates that the modification
14 is necessary because the pupil is a child with a disability, the
15 school district or public school academy may allow that additional
16 modification to the extent necessary because of the pupil's
17 disability if the group under subdivision (a) determines that the
18 modification is consistent with both the pupil's educational
19 development plan under subsection (11) and the pupil's
20 individualized education program. If the superintendent of public
21 instruction has reason to believe that a school district or a
22 public school academy is allowing modifications inconsistent with
23 the requirements of this subdivision, the superintendent of public
24 instruction shall monitor the school district or public school
25 academy to ensure that the school district's or public school
26 academy's policies, procedures, and practices are in compliance
27 with the requirements for additional modifications under this
28 subdivision. As used in this subdivision, "child with a disability"
29 means that term as defined in 20 USC 1401.



1 (l) If a pupil transfers to a school district or public school
 2 academy from out of state or from a nonpublic school, the pupil's
 3 parent or legal guardian may request, as part of the pupil's
 4 personal curriculum, a modification of the Michigan merit standard
 5 requirements that would not otherwise be allowed under this
 6 section. The school district or public school academy may allow
 7 this additional modification for a transfer pupil if all of the
 8 following are met:

9 (i) The transfer pupil has successfully completed at least the
 10 equivalent of 2 years of high school credit out of state or at a
 11 nonpublic school. The school district or public school academy may
 12 use appropriate assessment examinations to determine what credits,
 13 if any, the pupil has earned out of state or at a nonpublic school
 14 that may be used to satisfy the curricular requirements of the
 15 Michigan merit standard and this subdivision.

16 (ii) The transfer pupil's personal curriculum incorporates as
 17 much of the subject area content expectations of the Michigan merit
 18 standard as is practicable for the pupil.

19 (iii) The transfer pupil's personal curriculum requires the
 20 pupil to successfully complete at least 1 mathematics course during
 21 his or her final year of high school enrollment. In addition, if
 22 the transfer pupil is enrolled in the school district or public

4 (m) If a pupil is at least age 18 or is an emancipated minor,
5 the pupil may act on his or her own behalf under this subsection.

6 (n) This subsection does not apply to a pupil enrolled in a
7 high school that is designated as a specialty school under section
8 1278a(5) and that is exempt under that section from the English
9 language arts requirement under subsection (1)(a) and the social
10 science credit requirement under section 1278a(1)(a)(ii).

11 (o) The department or a school district or public school
12 academy shall not limit or discourage the number of pupils with a
13 personal curriculum on any basis other than the best interests of
14 each individual pupil.

15 (p) A school district or public school academy annually shall
16 notify each of its pupils and a parent or legal guardian of each of
17 its pupils that all pupils are entitled to a personal curriculum
18 under this subsection. The annual notice ~~shall~~**must** include an
19 explanation of what a personal curriculum is and state that if a
20 personal curriculum is requested, the public school or public
21 school academy will grant that request. The school district or
22 public school academy shall provide this annual notice to parents
23 and legal guardians by sending a written notice to each pupil's
24 home or by including the notice in a newsletter, student handbook,
25 or similar communication that is sent to a pupil's home, and also
26 shall post the notice on the school district's or public school
27 academy's website.

28 (6) If a pupil receives special education services, the
29 pupil's individualized education program, in accordance with the



1 individuals with disabilities education act, title VI of Public Law
2 91-230, ~~shall~~**must** identify the appropriate course or courses of
3 study and identify the supports, accommodations, and modifications
4 necessary to allow the pupil to progress in the curricular
5 requirements of this section and section 1278a, or in a personal
6 curriculum as provided under subsection (5), and meet the
7 requirements for a high school diploma.

8 (7) The board of a school district or board of directors of a
9 public school academy that operates a high school shall ensure that
10 each pupil is offered the curriculum necessary for the pupil to
11 meet the curricular requirements of this section and section 1278a.
12 The board or board of directors may provide this curriculum by
13 providing the credits specified in this section and section 1278a,
14 by using alternative instructional delivery methods such as
15 alternative course work, humanities course sequences, career and
16 technical education, industrial technology courses, or vocational
17 education, or by a combination of these. School districts and
18 public school academies that operate career and technical education
19 programs are encouraged to integrate the credit requirements of
20 this section and section 1278a into those programs.

21 (8) If the board of a school district or board of directors of
22 a public school academy wants its high school to be accredited
23 under section 1280, the board or board of directors shall ensure
24 that all elements of the curriculum required under this section and
25 section 1278a are made available to all affected pupils. If a
26 school district or public school academy does not offer all of the
27 required credits, the board of the school district or board of
28 directors of the public school academy shall ensure that the pupil
29 has access to the required credits by another means, such as



1 enrollment in a postsecondary course under the postsecondary
2 enrollment options act, 1996 PA 160, MCL 388.511 to 388.524;
3 enrollment in an online course; a cooperative arrangement with a
4 neighboring school district or with a public school academy; or
5 granting approval under section 6(6) of the state school aid act of
6 1979, MCL 388.1606, for the pupil to be counted in membership in
7 another school district.

8 (9) If a pupil is not successfully completing a credit
9 required for graduation under this section and section 1278a, or is
10 identified as being at risk of withdrawing from high school, then
11 the pupil's school district or public school academy shall notify
12 the pupil's parent or legal guardian or, if the pupil is at least
13 age 18 or is an emancipated minor, the pupil, of the availability
14 of tutoring or other supplemental educational support and
15 counseling services that may be available to the pupil under
16 existing state or federal programs, such as those programs or

21 (10) To the extent required by the no child left behind act of
22 2001, Public Law 107-110, **or the every student succeeds act, Public**
23 **Law 114-95** the board of a school district or public school academy
24 shall ensure that all components of the curricular requirements
25 under this section and section 1278a are taught by highly qualified
26 teachers. If a school district or public school academy
27 demonstrates to the department that the school district or public
28 school academy is unable to meet the requirements of this section
29 because the school district or public school academy is unable to



1 hire enough highly qualified teachers, the department shall work
2 with the school district or public school academy to develop a plan
3 to allow the school district or public school academy to hire
4 enough highly qualified teachers to meet the requirements of this
5 section.

6 (11) The board of a school district or board of directors of a
7 public school academy shall provide the opportunity for each pupil
8 to develop an educational development plan during grade 7, and
9 shall ensure that each pupil reviews his or her educational
10 development plan during grade 8 and revises it as appropriate
11 before he or she begins high school. The board of a school district
12 or board of directors of a public school academy shall also ensure
13 that each pupil reviews and revises his or her educational
14 development plan as appropriate during each year of high school. An

19 ~~shall~~**must** be based on high school readiness scores and a career
20 pathways program or similar career exploration program. An
21 educational development plan shall be designed to assist pupils to
22 identify career development goals as they relate to academic
23 requirements. During the process of developing and reviewing a
24 pupil's educational development plan, the pupil shall be advised
25 that many of the curricular requirements of this section and
26 section 1278a may be fulfilled through career and technical
27 education. In addition, during the process of developing and
28 reviewing an educational development plan, the pupil shall be
29 provided with all of the following:



1 (a) Information on various types of careers and current and
2 projected job openings in this state and those jobs' actual and
3 projected wages.

4 (b) An opportunity to explore careers specific to a pupil's
5 interests and identify career pathways and goals for achieving
6 success in those careers, including, but not limited to, the level
7 and type of educational preparation necessary to accomplish those
8 goals.

9 (c) An opportunity to develop a talent portfolio. A talent
10 portfolio shall be developed and revised throughout the
11 implementation of a pupil's educational development plan. A talent
12 portfolio ~~shall~~**must** include, but is not limited to, a record of
13 the pupil's experiences, proficiencies, certifications, or
14 accomplishments that demonstrate talents or marketable skills. The
15 department, in conjunction with the department of talent and
16 economic development, shall develop and make available to the
17 public schools model information materials that districts or public
18 school academies may use to comply with this subdivision.

19 (12) Except as otherwise provided in this subsection, if a
20 school district or public school academy is unable to implement all
21 of the curricular requirements of this section and section 1278a
22 for pupils entering grade 9 in 2007 or is unable to implement

25 **(13)** ~~(14)~~ This section and section 1278a do not prohibit a
 26 pupil from satisfying or exceeding the credit requirements of the
 27 Michigan merit standard under this section and section 1278a
 28 through advanced studies such as accelerated course placement,
 29 advanced placement, dual enrollment in a postsecondary institution,



1 or participation in the international baccalaureate program or an
2 early college/middle college program.

3 (14) ~~(15)~~ Not later than April 1 of each year, the department
4 shall submit an annual report to the legislature that evaluates the
5 overall success of the curriculum required under this section and
6 section 1278a, the rigor and relevance of the course work required
7 by the curriculum, the ability of public schools to implement the
8 curriculum and the required course work, and the impact of the
9 curriculum on pupil success, and that details any activities the
10 department has undertaken to implement this section and section
11 1278a or to assist public schools in implementing the requirements
