8 PROVISIONS CONCERNING APPROPRIATIONS

9 **GENERAL SECTIONS**

10 Sec. 201. In accordance with section 30 of article IX of the
 11 state constitution of 1963, total state spending from state sources
 12 in this appropriation act for the fiscal year ending September 30,
 13 2020 is \$0.00 and state spending from state sources to be paid to
 14 local units of government is \$0.00.

15 Sec. 202. The appropriations made and expenditures authorized
 16 under this act and the departments, commissions, boards, offices,
 17 and programs for which appropriations are made under this act are
 18 subject to the management and budget act, 1984 PA 431, MCL 18.1101
 19 to 18.1594.

20 **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

21 Sec. 301. From the funds appropriated in part 1 for community
 22 substance use disorder prevention, education, and treatment, the
 23 department shall allocate \$600,000.00 of federal state response to
 24 the opioid crisis grant revenue to create a competitive grant for
 25 recovery community organizations to offer or expand recovery
 26 support center services or recovery community center services to
 27 individuals seeking long-term recovery from substance use
 28 disorders. An organization may not receive a grant in excess of
 29 \$150,000.00. In awarding grants, priority shall be placed on



1 recovery community organizations that do the following:

2 (a) Provide recovery support navigation that includes the
3 following:

4 (i) Multiple recovery pathways.

5 (ii) Assisting individuals navigate recovery resources such as
6 detoxification, treatment, recovery housing, support groups, peer
7 support, and family support.

8 (iii) The promotion of community wellness and engagement.

9 (iv) Recovery advocacy that provides hope and encourages
10 recovery.

11 (v) A peer-led, peer-driven organization that offers recovery
12 to any individual seeking recovery from addiction.

13 (b) Provide recovery outreach education that includes the
14 following:

15 (i) On-site recovery education in the workplace.

16 (ii) All staff employee meetings.

17 (iii) On-site support for employees and family members.

18 (iv) Connections for employees and family members of employees
19 suffering from addiction to local recovery resources such as
20 treatment, recovery housing, and support groups.

21 (v) Connections with employers to provide recovery advocacy.

22 (c) Provide recovery activities and events that include the
23 following:

24 (i) Safe, ongoing recovery activities and events.

25 (ii) Opportunities to volunteer and participate in activities
26 and events.

27 (iii) Opportunities for family members and supporters of
28 recovery to be involved.



1 (iv) Meetings and activities on nutrition, health, and
2 wellness.

3 (v) Meetings and activities on mindfulness, meditation, and
4 yoga.
