

HOUSE BILL NO. 5158

A bill to amend 1985 PA 87, entitled
"William Van Regenmorter crime victim's rights act,"
by amending sections 8, 38, and 68 (MCL 780.758, 780.788, and
780.818), as amended by 2012 PA 457.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 8. (1) Based upon the victim's reasonable apprehension of
2 acts or threats of physical violence or intimidation by the
3 defendant or at defendant's direction against the victim or the
4 victim's immediate family, the prosecuting attorney **or the victim**
5 may move that the victim or any other witness not be compelled to



1 testify at pretrial proceedings or at trial for purposes of
2 identifying the victim as to the victim's address, place of
3 employment, or other personal identification without the victim's
4 consent. A hearing on the motion ~~shall~~**must** be in camera.

5 (2) The work address and address of the victim ~~shall~~**must** not
6 be in the court file or ordinary court documents unless contained
7 in a transcript of the trial or it is used to identify the place of
8 the crime. The work telephone number and telephone number of the
9 victim ~~shall~~**must** not be in the court file or ordinary court
10 documents except as contained in a transcript of the trial.
