A bill to amend 1965 PA 380, entitled "Executive organization act of 1965,"

(MCL 16.101 to 16.608) by adding section 130.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 130. (1) The department shall partner with the department
- 2 of health and human services to establish a joint advisory
- 3 committee that will develop and implement the initiative described





- 1 in subsection (2). Committee formation and membership must be
- 2 jointly determined by the department and the department of health
- 3 and human services.
- 4 (2) The committee shall develop and implement a joint
- 5 initiative to increase awareness among the veterans and family
- 6 members of veterans of this state of the programs and benefits for
- 7 which they may be eligible as veterans and family members of
- 8 veterans. All of the following apply to the initiative described in
- 9 this subsection:
- 10 (a) The initiative must have the title, "Ask the Question".
- 11 (b) The object of the initiative is to encourage public and
- 12 private agencies and organizations in the provider sector,
- 13 including, but not limited to, health care, social services, and
- 14 education, to ask the members of the populations they serve at the
- 15 point of contact, "Have you or a member of your family served in
- 16 the military?".
- 17 (c) If an individual answers the question in subdivision (b)
- 18 affirmatively, the committee shall encourage the agency or
- 19 organization described in subdivision (b) to provide the individual
- 20 with verbal guidance and printed information, developed and
- 21 distributed by the committee, regarding state and federal programs
- 22 or benefits that may be available to the individual as a veteran,
- 23 or as a family member of a veteran, including general information
- 24 regarding how and where to apply for or participate in those
- 25 programs or benefits.
- 26 (d) The committee shall provide advice and guidance to the
- 27 agencies and organizations described in subdivision (b) regarding
- 28 best practices for directing a veteran, or a family member of a
- 29 veteran, to a specific veterans' program or benefit that may be of



- 1 assistance to the veteran, or the family member of a veteran, in
- 2 regard to his or her specific need.
- 3 (3) The printed information distributed under subsection
- 4 (2)(c) must include a conspicuously placed disclaimer stating that
- 5 the provision of guidance or information regarding veterans'
- 6 programs and benefits that may be available to the individual
- 7 receiving that guidance or information is for informational
- 8 purposes only and is not an indication or determination of
- 9 eligibility for those programs or benefits.
- 10 (4) The department may share with the department of health and
- 11 human services information in its possession that is related to the
- 12 needs of veterans and family members of veterans if necessary to
- 13 facilitate the initiative described in this section, unless sharing
- 14 that information is a violation of a state or federal law
- 15 concerning privacy.
- 16 (5) As used in this section:
- 17 (a) "Committee" means the joint advisory committee established
- 18 under subsection (1).
- 19 (b) "Department" means the department of military and veterans
- 20 affairs.
- 21 Enacting section 1. This amendatory act does not take effect
