## **HOUSE BILL NO. 5444**

A bill to create the kinship caregiver navigator program; to provide for resources and services for kinship caregivers; to make appropriations for the kinship caregiver navigator program; and to prescribe the powers and duties for certain state departments and agencies.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the
  "kinship caregiver navigator act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Advisory council" means "council" as that term is defined

- 2 (b) "Department", "kinship caregiver", "kinship family", and
- 3 "relative" mean those terms as defined in the kinship caregiver
- 4 advisory council act.
- 5 (c) "Navigator" means an individual, knowledgeable about the
- 6 social and child welfare system, who is hired by the navigator
- 7 services provider to provide support services to kinship
- 8 caregivers.
- **9** (d) "Navigator program" means the kinship caregiver navigator
- 10 program established in section 3.
- 11 (e) "Navigator services provider" or "provider" means the
- 12 entity with whom the department contracts under section 3 to
- 13 provide navigator services to kinship caregivers.
- 14 Sec. 3. (1) The department shall establish and maintain the
- 15 kinship caregiver navigator program.
- 16 (2) Before participating in the navigator program, the
- 17 department must submit to the United States Department of Health
- 18 and Human Services Administration on Children, Youth and Families
- 19 an attachment to the state title IV-E plan. The attachment must
- 20 include, at a minimum, all of the following:
- 21 (a) The kinship navigator model the department shall utilize
- 22 to create the program. The department must provide an assurance
- 23 that this model meets the requirements of federal law.
- 24 (b) The date the navigator program began or will begin.
- 25 (c) Information describing the navigator program target
- 26 population and service area.
- 27 (d) Information on how the department will implement the
- 28 navigator program.
- 29 (3) The department shall enter into a contract with a third



- 1 party to provide navigator services to kinship caregivers.
- 2 (4) In addition to providing navigator services, the navigator
- 3 services provider shall establish a website regarding local support
- 4 groups, resources, and services for kinship caregivers. The website
- 5 must provide, at a minimum, information on the following:
- 6 (a) Outreach.
- 7 (b) Educational information.
- 8 (c) Training materials.
- 9 (d) Financial assistance.
- 10 (e) Legal services, including, but not limited to, pro bono
- 11 and low bono legal aid providers, forms needed to file a petition
- 12 in court, guides to kinship care legal issues, and any other
- 13 information the provider considers necessary.
- 14 (f) Health care, mental health, and substance use disorder
- 15 services.
- 16 (g) Child and respite care.
- 17 (h) Support groups.
- 18 (i) Parenting tips.
- 19 (j) Resources for caring for children with special needs.
- 20 (5) The navigator services provider shall establish and
- 21 maintain a single statewide toll-free telephone number for kinship
- 22 caregivers to call for information or services.
- 23 Sec. 4. The navigator services provider shall do all of the
- 24 following:
- 25 (a) Consult with the advisory council on the design and
- 26 continuation of the navigator program.
- 27 (b) Consult with the advisory council on developing outreach
- 28 and educational material to provide to kinship families.
- 29 (c) Promote partnerships between public and private agencies



- 1 to increase knowledge of the needs of kinship families and to
- 2 increase responsiveness to those needs. This includes working with
- 3 other navigation systems for foster care and adoption, as well as
- 4 for general information and referral systems.
- 5 (d) Develop training material for navigators that is based on6 industry best practices.
- 7 (e) Share aggregate data with the advisory council regarding
- 8 who is being served under the navigator program and what services
- 9 are being provided. The provider shall not share information on
- 10 individual identification under this subdivision.
- Sec. 5. The navigator program shall do all of the following:
- 12 (a) Assist kinship caregivers in learning about, finding, and
- 13 using programs and services to meet the needs of the children they
- 14 are raising.
- 15 (b) Work with state, local, and nonprofit agencies that
- 16 promote service coordination or provide information and referral
- 17 services.
- 18 (c) Establish information and referral systems that link, by
- 19 toll-free access, kinship caregivers, kinship support group
- 20 facilitators, and kinship caregiver service providers to each
- 21 other. This information and referral systems shall include, but are
- 22 not limited to, the following:
- 23 (i) Eligibility and enrollment information.
- (ii) Relevant training to assist kinship caregivers in
- 25 caregiving.

- (iii) Connections to legal aid and assistance providers.
- 27 (d) Comply with all federal regulations and statutes,
- 28 including the provisions of 42 USC 627 and 671, to qualify for
- 29 reimbursement of 50% of the costs for the kinship caregiver

- 2 Sec. 6. The navigator services provider may do all of the
- 3 following:
- 4 (a) Identify and maintain relationships with the State Bar of
- 5 Michigan, law school clinics, and other nonprofit legal services
- 6 agencies. These relationships shall facilitate developing a county
- 7 or regional pro bono or low bono legal representation referral
- 8 program.
- **9** (b) Develop and maintain training materials and training
- 10 programs designed to educate pro bono, low bono, or both, attorneys
- 11 on how to provide legal advice, assistance, and representation
- 12 specific to kinship caregivers.
- 13 (c) Apply for and accept grants from other public or private
- 14 entities to develop legal services initiatives.
- Sec. 7. (1) The kinship caregiver navigator fund is created
- 16 within the state treasury.
- 17 (2) The state treasurer may receive money or other assets from
- 18 any source for deposit into the fund. The state treasurer shall
- 19 direct the investment of the fund. The state treasurer shall credit
- 20 to the fund interest and earnings from fund investments.
- 21 (3) Money in the fund at the close of the fiscal year shall
- 22 remain in the fund and shall not lapse to the general fund.
- 23 (4) The department's children's services agency shall be the
- 24 administrator of the fund for auditing purposes.
- 25 (5) The department's children's services agency shall expend
- 26 money from the fund, upon appropriation, only for the purpose of
- 27 carrying out the provisions of this act.
- Enacting section 1. This act takes effect October 1, 2020.
