## **HOUSE BILL NO. 6224**

September 15, 2020, Introduced by Reps. Lasinski, LaGrand, Stone and Peterson and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure,"

by amending section 22 of chapter XVII (MCL 777.22), as amended by 2003 PA 134, and by adding section 49b to chapter XVII.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

CHAPTER XVII
Sec. 22. (1) For all crimes against a person, score offense
variables 1, 2, 3, 4, 7, 8, 9, 10, 11, 12, 13, 14, 19, and 20.
Score offense variables 5 and 6 for homicide, attempted homicide
conspiracy or solicitation to commit a homicide, or assault with
