A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1179c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1179c. (1) Beginning with the 2021-2022 school year, the board of a school district or intermediate school district or board of directors of a public school academy shall require that all school personnel employed by, or assigned to work at, a school operated by the school district, intermediate school district, or public school academy successfully complete seizure recognition and

- 1 (3) The department shall develop guidelines regarding the 2 trainings described in subsections (1) and (2). The guidelines
- 3 described in this subsection and the trainings described in
- 4 subsections (1) and (2) must be consistent with guidelines
- 5 developed by a national nonprofit organization dedicated to
- 6 epilepsy and seizures.
- 7 (4) For each pupil who is being treated for a seizure
- 8 disorder, the board of the school district or intermediate school
- 9 district or board of directors of the public school academy in
- 10 which the pupil is enrolled shall ensure that a seizure action plan
- 11 submitted by the pupil's parent or legal guardian is made a part of
- 12 the pupil's school record. A seizure action plan described in this

- 15 (b) The name and purpose of any medication that the pupil is

- 19 (d) The route of administration of the prescription described

- 21 (e) The frequency with which the medication described in
- 22 subdivision (b) may be administered.
- 23 (f) The circumstances under which the medication described in
- 24 subdivision (b) may be administered.
- 25 (5) The board of a school district or intermediate school
- 26 district or board of directors of a public school academy shall
- 27 ensure that a seizure action plan described in subsection (4) is
- 28 made accessible to all school personnel who are responsible for the
- 29 pupil to whom the plan applies.



- (6) Notwithstanding any school, school district, or 1 2 intermediate school district policy to the contrary, upon written 3 permission by a pupil's parent or legal guardian, the board of the 4 school district or intermediate school district or board of directors of the public school academy in which the pupil is 5 6 enrolled shall ensure that at least 1 employee of the pupil's 7 school is designated by the school administrator to administer 8 seizure medication to the pupil in compliance with the instructions 9 of a physician if the pupil has a prescription for the medication 10 on file at the school. The board or board of directors shall ensure 11 that its local policy concerning the administration of medications to pupils at school is modified, as needed, to comply with this 12 13 subsection. The department shall identify, develop, and adopt 14 appropriate revisions to any medication administration guidelines 15 issued by the department including, but not limited to, those relating to the training needs and requirements for the 16 administration and maintenance of seizure medication, as needed, to 17 18 comply with this subsection. Any medication administered under this 19 subsection must be approved by the United States Food and Drug 20 Administration.
 - (7) Subject to section 1178, a school district, intermediate school district, public school academy, school board member, intermediate school board member, board of directors member of a public school academy, or employee of a school district, intermediate school district, or public school academy who in good faith carries out an act to comply with this section in accordance with this section is not liable in a criminal action or for civil damages as a result of that act, except for an act or omission amounting to gross negligence. As used in this subsection, "gross

- 1 negligence" means that term as defined in section 7 of 1964 PA 170,
- 2 MCL 691.1407. This subsection does not eliminate, limit, or reduce
- 3 any other immunity or defense that a school district, intermediate
- 4 school district, public school academy, member of a school board,
- 5 member of an intermediate school board, board of directors member
- 6 of a public school academy, or employee of a school district,
- 7 intermediate school district, or public school academy may have
- 8 under other state law.
- 9 (8) As used in this section, "school personnel" means a school
- 10 administrator, guidance counselor, teacher, or other relevant
- 11 school employee with direct contact and supervision of pupils,
