SENATE BILL NO. 105

February 12, 2019, Introduced by Senator VANDERWALL and referred to the Committee on Natural Resources.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 35317 (MCL 324.35317), as amended by 2012 PA 297.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 35317. (1) A local unit of government may issue variances
- 2 under a zoning ordinance, or the department may issue special
- 3 exceptions under the model zoning plan if a local unit of
- 4 government does not have an approved zoning ordinance, if a

- 1 practical difficulty will occur to the owner of the property if the
- 2 variance or special exception is not granted. In determining
- 3 whether a practical difficulty will occur if a variance or special
- 4 exception is not granted, primary consideration shall be given to
- 5 ensuring both of the following: assuring that
- (a) The protection of human health and safety. are protected
 by the determination and that the determination complies
- 8 (b) Compliance with applicable local zoning, other state laws,9 and federal law.
- 10 (2) If a practical difficulty will occur to the owner of the
 11 property if the variance or special exception is not granted, a
 12 variance or special exception shall be granted under this section
 13 unless the local unit of government or the department determines
 14 that the use will significantly damage the public interest on the
 15 privately expecting or if the land is publicly expect the public
- 15 privately owned land, or, if the land is publicly owned, the public
- 16 interest in the publicly owned land, by significant and
- 17 unreasonable depletion or degradation of any of the following:
- 18 (a) The diversity of the critical dune areas within the local19 unit of government.
- 20 (b) The quality of the critical dune areas within the local21 unit of government.
- (c) The functions of the critical dune areas within the localunit of government.
- (3) (2) The decision of the local unit of government or the department shall be in writing and shall be based upon evidence that would meet the standards in section 75 of the administrative procedures act of 1969, 1969 PA 306, MCL 24.275. A decision denying a variance or special exception shall document, and any review upholding the decision shall determine, all of the following:

- (a) That the local unit of government or the department has
 met the burden of proof under subsection (1).(2).
- 3 (b) That the decision is based upon sufficient facts or data.
- 4 (c) That the decision is the product of reliable scientific5 principles and methods.
- 6 (d) That the decision has applied the principles and methods7 reliably to the facts.
 - (e) That the facts or data upon which the decision is based are recorded in the file.

- (4) (3) A local unit of government or the department shall not
 require an environmental site assessment or environmental impact
 statement for a variance except for a special use project.
 - (5) (4)—A variance shall not be granted from a setback requirement provided for under the model zoning plan or an equivalent zoning ordinance approved under section 35034—35304 enacted pursuant to this part unless the property for which the variance is requested is 1 of the following:
- 18 (a) A nonconforming lot of record that is recorded prior to
 19 July 5, 1989, and that becomes nonconforming due to the operation
 20 of this part or a zoning ordinance.
 - (b) A lot legally created after July 5, 1989 that later becomes nonconforming due to natural shoreline erosion.
- (c) Property on which the base of the first landward critical dune of at least 20 feet in height that is not a foredune is located at least 500 feet inland from the first foredune crest or line of vegetation on the property. However, the setback shall be a minimum of 200 feet measured from the foredune crest or line of vegetation.
 - (6) (5) Each local unit of government that has issued a

variance for a use other than a special use project during the
previous 12 months shall file an annual report with the department
indicating variances that have been granted by the local unit of
government during that period.

5 (7) (6) Upon receipt of an application for a special exception 6 under the model zoning plan, the department shall forward a copy of 7 the application and all supporting documentation to the local unit 8 of government having jurisdiction over the proposed location. The 9 local unit of government shall have has 60 days to review and 10 comment on the proposed special exception. The department shall not 11 make a decision on a special exception under the model zoning plan 12 until either the local unit of government has commented on the proposed special exception or has waived its opportunity to review 13 14 the special exception. The local unit of government may waive its 15 opportunity to review the application at any time within 60 days 16 after receipt of the application and supporting documentation by notifying the department in writing. The local unit of government 17 18 also waives its opportunity to review the application if it fails to act as authorized in this subsection within 60 days. If the 19 20 local unit of government waives its opportunity to review the application, the local unit of government also waives its 21 opportunity to oppose the decision by the department to issue a 22 23 special exception. If the local unit of government opposes the 24 issuance of the special exception, the local unit of government 25 shall notify notifies the department, in writing, of its opposition within the 60-day notice period, . If that the local unit of 26 27 government opposes the issuance of the special exception, the department shall not issue a special exception. The local unit of 28 29 government may also consider whether a practical difficulty will

- 1 occur to the owner of the property if the special exception is not
- 2 granted by the department and may make a recommendation to the
- 3 department within the 60-day notice period. The department shall
- 4 base its determination of whether a practical difficulty exists on
- 5 information provided by the local unit of government and other
- 6 pertinent information.
- 7 (8) Notwithstanding any other provision of this section, upon
- 8 application, the department shall issue a special exception under
- 9 this section if all of the following conditions are met:
- 10 (a) The applicant is a local unit of government and the
- 11 application involves public land that was public land on July 5,
- 12 1989.
- 13 (b) The purpose of the application is to provide a view of 1
- 14 of the Great Lakes, from a parking lot that was lawful and in
- 15 existence on July 5, 1989.
- 16 (c) The special exception is for a proposed project that would
- 17 benefit the citizens and visitors of that local unit of government
- 18 as evidenced by the adoption of a resolution in support of the
- 19 special exception by the governing body of that local unit of
- 20 government.
- 21 (d) The resolution adopted under subdivision (c) demonstrates
- 22 that the proposed project would meet the criteria set forth in
- 23 section 35302.
- 24 Enacting section 1. This amendatory act takes effect 90 days
- 25 after the date it is enacted into law.
