SENATE RESOLUTION NO.130

Senator MacDonald offered the following resolution:

- 1 A resolution to memorialize the Congress of the United States
- 2 to explore further avenues of relief for businesses affected by the
- 3 COVID-19 Pandemic.
- 4 Whereas, The COVID-19 Pandemic has dramatically affected
- 5 Michigan and the United States. The first cases in Michigan were
- 6 reported on March 10, 2020, and since these initial reports more
- 7 than 56,000 cases have been confirmed and more than 5,000
- 8 Michiganders have lost their lives to the novel coronavirus.
- 9 Nationally, there have been more than 1.7 million cases and 100,000
- 10 deaths; and
- 11 Whereas, Mitigating the spread of the virus has required
- 12 extraordinary public health measures. Governor Gretchen Whitmer has
- 13 issued executive orders prohibiting large gatherings, closing all

- 1 primary and secondary schools, and requiring the temporary closure
- 2 of all nonessential businesses. At the federal level, the White
- 3 House Coronavirus Task Force's guidelines recommended the closure
- 4 of places where people gather, including businesses, where there is
- 5 evidence of community transmission. While some industries and
- 6 regions of the state have begun to partially reopen, it is unclear
- 7 how long mitigation measures will be necessary before normal
- 8 operations can resume; and
- **9** Whereas, These measures have greatly impacted the livelihoods
- 10 of business owners across the state and our nation. With the forced
- 11 closures, small business owners have been forced to lay off workers
- 12 and forgo income for months, while still needing to make payments
- 13 for utilities, mortgages and rent, and other expenses. According to
- 14 a survey by the Small Business Administration of Michigan, one in
- 15 seven, or about 14 percent, of small businesses are not confident
- 16 that they will survive the Pandemic. Nationally, a survey found
- 17 that 7.5 million small businesses are at risk of shutting down; and
- 18 Whereas, Federal and state governments have a responsibility
- 19 to assist small businesses since government mitigation measures,
- 20 while for the greater good, contributed significantly to the
- 21 current economic crisis. The economic uncertainty and devastation
- 22 caused by the COVID-19 Pandemic and the related mitigation policies
- 23 are not the fault of small business owners. It would be unjust to
- 24 fail to help them and to allow them to bear an unfair share of the
- 25 burden of addressing this crisis; and
- 26 Whereas, The failure of these businesses could have wide
- 27 ranging negative effects for Michigan and the United States. Since
- 28 the beginning of the crisis, more than 40 million Americans have
- 29 filed for unemployment, including more than 1.7 million in

- 1 Michigan. If small businesses are unable to reopen, many of these
- 2 claimants may not be able to return to work, magnifying the already
- 3 devastating economic impact of COVID-19; and
- 4 Whereas, The small business relief already enacted by Congress
- 5 is not sufficient to mitigate these effects. As part of the
- 6 Coronavirus Aid, Relief, and Economic Security (CARES) Act,
- 7 Congress created the Paycheck Protection Program (PPP) to provide
- 8 loans to small businesses. Even though additional money was
- 9 subsequently appropriated to the program, the PPP has been unable
- 10 to prove relief to millions of small businesses that have been
- 11 affected by the crisis; now, therefore, be it
- 12 Resolved by the Senate, That we memorialize the Congress of
- 13 the United States to explore further avenues of relief for
- 14 businesses affected by the COVID-19 Pandemic; and be it further
- 15 Resolved, That copies of this resolution be transmitted to the
- 16 Speaker of the United States House of Representatives, the
- 17 President of the United States Senate, and the members of the
- 18 Michigan congressional delegation.
