Rep. Huizenga:

We understand the importance of adoption and honor those who choose an adoption plan and those who provide children with a loving home; now, therefore, be it

A resolution to declare November 14-20, 2021, as Thyroid Eye Disease Awareness Week in the state of Michigan. Whereas, Thyroid Eye Disease (TED) is a serious, progressive and rare autoimmune condition in which the body's immune system mistakenly attacks healthy muscle and fat tissue behind the eye, causing inflammation and scar tissue to form; and

Whereas, People living with TED often have debilitating symptoms of eye bulging, double vision, blurred vision, and pain and facial disfigurement. In severe cases, TED can lead to blindness; and

Whereas, People living with TED often experience long-term impact on functional, psychosocial and economic burdens, including the inability to work or perform activities of daily living; and

Whereas, The exact underlying process by which TED occurs is not fully understood. TED is a serious, vision threatening condition that can get worse over time; and

Whereas, TED is a rare disease and is estimated to have a prevalence of 16 per 100,000 women and 2.9 per 100,000 men in the general population and

Whereas, A diagnosis of TED is based upon identification of characteristic symptoms, a detailed patient history, a thorough clinical evaluation and a variety of specialized tests; and

Whereas, There is a genetic component to the condition and people who have a family member with the disease or a family member with an autoimmune disease are at a greater risk of developing the condition; and

Whereas, TED Awareness Week has been established through a collaboration among advocacy organizations including the American Autoimmune Related Diseases Association, Inc (AARDA), and Prevent Blindness. AARDA and Prevent Blindness are engaged in disease awareness and patient support; now, therefore, be it

Resolved by the House of Representatives, That the members of this legislative body declare November 14-20, 2021, as Thyroid Eye Disease Week in the state of Michigan.

Whereas, The MotorCities National Heritage Area is the largest concentration of auto-related sites, attractions, and events in the world, bringing in millions of visitors each year; and

Whereas, Annually, the MotorCities National Heritage Area generates \$490 million in economic impact, including \$40 million in tax revenue and over 5,300 jobs; and

Whereas, For the eighth consecutive year, the MotorCities National Heritage Area, in partnership with the Michigan Legislative Auto Caucus, has organized Michigan Auto Heritage Day, where supporters of automotive heritage preservation come together in celebration of the state's unique automotive history; and

Whereas, The Michigan Legislative Auto Caucus allows members to exchange ideas and influence policy, including auto heritage policy; now, therefore, be it

Resolved by the House of Representatives, That the members of this legislative body declare November 17, 2021, as Auto Heritage Day in the state of Michigan.

Whereas, We all hold the responsibility to future generations to ensure they have the ability and right to live in a clean and sustainable Michigan; and

Whereas, Michigan's recycling rate is around only 15% when the national recycling rate is 32%; and

Whereas, Recycling not only has a positive impact on the environment, but also provides an economic benefit. Research shows that recycling and reuse activities nationwide accounted for 681,000 jobs and \$37.8 billion in wages. A 2017 state recycling report states that over \$600 million recoverable materials end up in landfills, costing the state of Michigan over 1 billion dollars; and

Whereas, In the year 2020, the total waste disposal in Michigan landfills was reported at 52,697,247 cubic yards; and Whereas, Recycling conserves resources such as timber, water, and minerals. Recycling protects the environment by reducing the amount of waste in landfills and combustion facilities, as well as the amount of plastic in Michigan's waterways; and

Whereas, Approximately 9,887 metric tons of plastic debris per year enter the Laurentian Great Lakes. The Great Lakes make up about 21% of the world's supply of surface fresh water and 84% of North America's surface fresh water; and

Whereas, It is estimated that 138,000 new jobs would be created if Michigan's recycling rate tripled to 45%. This would provide \$9 billion in annual labor income and \$33.8 billion in economic output. This would also eliminate emission of an additional 7 million metric ton equivalent of carbon dioxide; and

Whereas, We celebrate Michiganders' continued dedication to reduce, reuse, and recycle; now, therefore, be it

Resolved by the House of Representatives, That the members of this legislative body declare November 15-21, 2021, as Recycling Week in the state of Michigan. We demonstrate our state's commitment to sustainability. The act of recycling, both at the individual and industrial level, help support a healthier and more economically prosperous Michigan.
