# FY 2020-21 and FY 2021-22 SUPPLEMENTAL APPROPRIATIONS

Summary: Conference Report House Bill 4398 (H-3) CR-1\*

## **Overview**

House Bill 4398 (H-3) CR-1\* contains supplemental appropriation adjustments to multiple budget areas for FY 2020-21 and FY 2021-22. In sum, FY 2020-21 adjustments increase Gross appropriations in the state budget by \$116.8 million and increase GF/GP appropriations by \$1.0 million. FY 2021-22 adjustments increase Gross appropriations by \$724.8 million and increase GF/GP appropriations by \$70.2 million.

Appropriation and boilerplate priorities initiated by the State Budget Office in requests 2021-11 and 2022-1, and priorities initiated by the legislature, are identified in this document.

# FY 2021-22 Supplemental Boilerplate Items

### **GENERAL SECTIONS**

# Sec. 201. State Spending and State Appropriations Paid to Local Units of Government

States amount of state spending from state sources in the bill and amount of state spending to be paid to local units of government.

# Sec. 202. Appropriations Subject to Management and Budget Act

Subjects appropriations to the Management and Budget Act, 1984 PA 431.

# Sec. 203. State Administrative Board Transfers

Authorizes the legislature, by a concurrent resolution adopted by a majority of the members elected to and serving in each house, to inter-transfer funds if the State Administrative Board transfers funds.

# Sec. 204. Appropriations Subject to Federal Audit and Reporting Requirements

Subjects appropriations to applicable federal audit and reporting requirements; requires prompt action if instances of noncompliance are identified; requires the state budget director to notify appropriations committees and fiscal agencies of incidences of noncompliance.

# Sec. 205. Report on Status of ARPA Appropriations

Requires the state budget director to report on the status of all funds appropriated related to the coronavirus relief effort on a monthly basis until all funds are exhausted.

# **EDUCATION**

#### Sec. 301. Teacher Talent Pipeline

Requires funding to be used to provide grants to an eligible education-related nonprofit organization that supports teacher recruitment, training, development and retention; designates unexpended funds as a work project appropriation.

#### FY 2021-22 Supplemental Boilerplate Items

#### Sec. 302. PRIME Schools

Requires funding for the SME Education Foundation's Partnership Response in Manufacturing Education (PRIME) initiative to be used to provide high schools with cost effective and tailored engineering and manufacturing education; authorizes the Department of Educations to use a portion of the appropriation for staffing and administration of the initiative.

### **HEALTH AND HUMAN SERVICES**

#### Sec. 401. Child and Adolescent Health Care and Centers

State legislative intent that the funds appropriated for child and adolescent health care and centers support primary health care and services to children and adolescents; requires DHHS and Department of Education to jointly determine expenditure of the funds.

#### Sec. 402. ARP - Epidemiology and Laboratory Capacity School Safety

Requires DHHS to purchase supplies for distribution to school systems for coronavirus testing and contract tracing for students, staff, and others, and allows 1% of funds for administrative costs of Michigan Association of Intermediate School Administrators; allows school districts to opt for direct reimbursement instead of direct supply, with timelines; requires DHHS to maintain a public website of supply procurement options for schools; prohibits state or local government entities from retrieving supplies without consent of a school district; requires any redistribution of such supplies to be done by the association; requires DHHS to collaborate with the Department of Education.

#### Sec. 403. Behavioral Health Substance Use Disorder Pilot

Requires funding to be used for an online and interactive version of the protected health information consent tool; places specific conditions on grantee experience and requirement for training, application of the substance use disorder health information technology plan, and integration of the consent tool with other applications.

# Sec. 404. COVID-19 Epidemiology and Laboratory Capacity Nursing Home and Long-Term Care Strike Teams

Requires DHHS to recruit qualified out-of-state persons to staff a nursing home and long-term care strike team to assist in providing care at treatment facility that experiences a temporary staffing shortage.

#### Sec. 405. COVID-19 Substance Abuse Prevention and Treatment Block Grant

Requires DHHS to provide grants to local public entities that provide substance use disorder services and to 1 private entity that has a statewide contract to provide community-based substance use disorder services.

# Sec. 406. Federal Mental Health Block Grant

Requires DHHS to provide grants to local public entities that provide substance use disorder services and to 1 private entity that has a statewide contract to provide community-based mental health services.

# Sec. 407. Injury Control Intervention – Traumatic Brain Injury

Modifies current section 1971 in 2021 PA 87 by including requirement that software purchases are to be made from the same entity used for purchases in FY 2018-19; designates unexpended funds as a work project appropriation.

#### Sec. 408. Mental Health Crisis Services

Allocates \$100,000 for mental health crisis services to a nonprofit mental health crisis services organization in Oakland County.

#### LABOR AND ECONOMIC OPPORTUNITY

# Sec. 501. At-Risk Youth Grants

Requires appropriation to be awarded to the Michigan franchise holder of the national Jobs for America's Graduates program and to leverage non-state contributions to the Michigan franchise holder of the national Jobs for America's Graduates program.

# Sec. 502. Arts and Culture Programs

Requires funding be used to support programming and general operating expenses, to cover up to 100% of the costs of the programs which grants support, to prevent, prepare for, respond to, and recover from the COVID-19 pandemic, with a priority on opening for inperson activities.

# Sec. 503. COVID-19 Emergency Rental Assistance

Requires LEO to work with DHHS, Judiciary, and local agencies to operate an emergency rental and utility assistance program; requires program to operate under federal rules and to serve eligible households to help keep housing and avoid eviction; requires households to provide specific documentation to show eligibility; prohibits funding from being used for rent owed for occupancies after September 30, 2022; requires a report.

#### Sec. 504. Distribution of One-Time Grants Appropriation

Requires appropriation for One-Time Grants to be allocated as follows: \$1.0 million to Making it Happen Foundation; \$951,000 for road renovation and realignment projects in the City of Hudsonville; \$5.0 million for converting the 10th floor of Helen DeVos Children's Hospital to a 12-bed pediatric psychiatric unit; \$2.5 million for Great Lakes Center for Autism for expansion of pediatric autism services; \$2.5 million for Allegan County Community Mental Health Crisis and Stabilization Unit and Clinic; \$9.0 million for the North American International Auto Show; and \$1.0 million for the St. Clair Convention Center.

#### Sec. 601. Appropriation of Private Revenues at State Veterans Homes
