INCREASE FINES FOR CERTAIN ASSAULTS OF EMERGENCY ROOM PERSONNEL

SUMMARY:

House Bill 5682 would amend the Michigan Penal Code to create enhanced penalties for simple assault, aggravated assault, and assault with a deadly weapon of a person who works in an emergency room and is performing his or her duties at the time of the crime. The enhanced penalties would increase (double) the potential fines for the offenses. The potential terms of imprisonment would not be changed.

Simple assault

Currently, if the law prescribes no other penalty, a person who assaults or assaults and batters an individual is guilty of a misdemeanor punishable by imprisonment for up to 93 days or a fine of up to \$500, or both.

The bill would add that if the victim of a violation described above is a member of *emergency room personnel* and the violation occurs while the victim is performing his or her duties as a member of emergency room personnel, the person is guilty of a misdemeanor punishable by imprisonment for up to 93 days or a fine of up to \$1,000, or both.

Aggravated assault

Currently, except in specified circumstances, a person who assaults an individual without a weapon and inflicts serious or aggravated injury on that individual without intending to commit murder or inflict great bodily harm less than murder is guilty of a misdemeanor punishable by imprisonment for up to one year or a fine of up to \$1,000, or both.

The bill would add that if the victim of a violation described above is a member of *emergency room personnel* and the violation occurs while the victim is performing his or her duties as a member of emergency room personnel, the person is guilty of a misdemeanor punishable by imprisonment for up to one year or a fine of up to \$2,000, or both.

Assault with a deadly weapon

Currently, except in specified circumstances, a person who assaults an individual with a gun, knife, iron bar, club, brass knuckles, or other dangerous weapon without intending to commit murder or inflict great bodily harm less than murder is guilty of a felony punishable by imprisonment for up to four years or a fine of up to \$2,000, or both.

The bill would add that if the victim of a violation described above is a member of *emergency room personnel* and the violation occurs while the victim is performing his or her duties as a member of emergency room personnel, the person is guilty of a felony punishable by imprisonment for up to four years or a fine of up to \$4,000, or both.

For purposes of the bill, *emergency room personnel* would include physicians, clerks, intake clerks, and any other individuals employed in the emergency department or emergency room of a hospital licensed under Article 17 of the Public Health Code.

The bill would take effect 90 days after its enactment.

FISCAL IMPACT:

House Bill 5682 would have an indeterminate fiscal impact on the state and on local units of government. The number of convictions that would result under provisions of the bill is not known. Any increase in penal fine revenue would increase funding for public and county law libraries, which are the constitutionally designated recipients of those revenues.
