Boilerplate Changes from FY 2021-22 Year-to-Date:

1. **Communications with Legislators.** The **Governor** deleted the prohibition of departments taking disciplinary action against employees communicating with Legislators or their staff. The **Senate** retained. (Sec. 206)
2. **Consistency with Statute for Travel Report.** The **Governor** added language specifying that travel report requirements are to comply with statute and apply to departments and agencies receiving appropriations in part 1. The **Senate** retained. (Sec. 207)
3. **Reimbursement for Legal Services.** The **Governor** included language prohibiting departments and agencies from hiring outside counsel for legal services that are the responsibility of the Attorney General. The **Senate** revised to permit such use and allow departments to request reimbursement from Attorney General appropriations for this purpose. (Sec. 208)
4. **General Fund Lapse Report.** The **Governor** modified the report date from November 30 to December 31. The **Senate** retained. (Sec. 209)
5. **Budget Stabilization Fund.** The **Governor** recommended zero deposits into the BSF for FY 2022-23. The **Senate** concurred. (Sec. 210)
6. **FTE Quarterly Report.** The **Governor** deleted the quarterly report on FTEs and remote work. The **Senate** retained. (Sec. 216)
7. **Work Project Prioritization.** The **Governor** deleted the requirement that work project appropriation be used prior to new appropriations. The **Senate** retained. (Sec. 217)
8. **State Administrative Board Transfers.** The **Governor** deleted the section that allows the Legislature to vote in concurrent to funds transferred by the State Administrative Board. The **Senate** retained. (Sec. 218)
9. **Retention of Report.** The **Governor** deleted the section requiring departments to retain copies of reports. The **Senate** retained. (Sec. 219)
10. **Policy Change Reporting Requirement.** The **Governor** deleted a report due April 1 that requires each department to specify policy changes made to implement enacted legislation. The **Senate** retained. (Sec. 220)
11. **General Fund Prioritization.** The **Governor** deleted the prohibition on the departments from using General Fund appropriations where Federal and Private Funds are available. The **Senate** retained. (Sec. 221)
12. **Severance Pay Report.** The **Governor** deleted reporting and webpage requirements related to severance pay for certain department officials. The **Senate** retained. (Sec. 222)
13. **COVID-19 Vaccine Passport.** The **Governor** deleted prohibitions on certain government agencies or bodies from requiring a vaccine or vaccine passport as well as other vaccine-related language. The **Senate** retained. (Sec. 225)
14. **Auditor General.** The **Governor** deleted the requirement that departments report within six months after an audit with implementation of any identified initiatives related to savings and efficiencies found by the Auditor General and required the auditor general to conduct another audit on any noncompliant departments and charge the corresponding department for the cost of performing another audit. The **Senate** retained. (Sec. 229)
15. **Contingency Plan.** The **Governor** removed the requirement that the State Budget Director issue a report that includes a contingency plan if Federal funding reduces \$10.0 million or a 10% reduction. The **Senate** retained. (Sec. 235)
16. **Return on Taxpayer Investment.** The **Governor** deleted the requirement that the State Budget Director list new or increase programs over \$500,000 in the Governor's budget recommendation, establish metrics for measuring the programs listed, and providing an update on the metrics of those programs in two years. The **Senate** retained. (Sec. 240)
17. **Technical Modification.** The **Governor** made a number of technical adjustments such as revised dates, spending totals, definitions, and moving department budgets to individual articles. The **Senate** retained but made appropriate updates regarding funding totals and years. (Secs. 201, 203, 204, 209, 210, 211, and 212)

1. **Deleted Sections.** The **Governor/Senate** deleted a number of sections, which include: 924 (John R Justice Grant Program), 949k (Transportation Administration Support Fund), 949n (NextGen Infrastructure), and 949o (Local First Responder Recruitment and Training Grants).
2. **Contingency Fund Authorization.** The **Governor** included the contingency fund authorization for Federal funds from \$500,000 to \$1.0 million, Local funds from \$100,000 to \$200,000, and Private funds from \$20,000 to \$40,000. The **Senate** deleted the section. (Sec. 901)
3. **Tax Collection Contracts.** The **Governor/Senate** modified the language for tax collection contracts to support the infrastructure for tax collection. (Sec. 903)
4. **Notification of Revenue Administrative Bulletins.** The **Governor** modified the notification of Revenue Administrative Bulletins to five days after a bulletin's posting. The **Senate** maintained current language. (Sec. 921)
5. **Michigan Financial Authority.** The **Governor** modified the language for the Michigan Financial Authority to remove the reporting requirement. The **Senate** maintained current language. (Sec. 934)
6. **Financial Independence Team.** The **Governor** deleted the section regarding the cooperation of the Financial Independence Team with the Department of Education. The **Senate** retained the section. (Sec. 947)
7. **Employment Opportunity Fund (NEW).** The **Governor/Senate** included new language that allows the department to capture tax revenue and make payments from the Employment Opportunity Fund in accordance with the Michigan Strategic Fund Act, Chapter 8f. (Sec. 949g)
8. **Fostering Futures Scholarship Trust Fund (NEW).** The **Governor/Senate** included new language that allows the department to deposit any gifts or donations for the Fostering Futures Scholarship Trust Fund and make those deposits available for expenditure in accordance with the Fostering Futures Scholarship Trust Fund Act. (Sec. 949n)
9. **Blight Elimination (NEW).** The **Senate** included new language to appropriate the Blight Elimination grants throughout the State and rural communities. (Sec. 949o)
10. **Jobs Court (NEW).** The **Senate** included new language to appropriate the \$5.0 million for Jobs Court to create a prison diversion pilot program with the Attorney General in three counties. (949p)
11. **Land and Housing (NEW).** The **Senate** included new language to appropriate three \$100 placeholders for three programs, first to encourage increase to housing supply and affordability, second to provide credits to entities that provide housing for employees, and third to appropriate 4.0 FTEs to consolidate and add development tax exemption information to the electronic local government information system (Sec. 949q)
12. **Placeholder (NEW).** The **Senate** included new language to appropriate \$100 for late-qualifying manufacturing personal property tax reimbursement upon enactment and in accordance with SB 807. (Sec. 949s)

13. **Local Financial Data System (NEW).** The **Senate** appropriated \$300,000 from the Local Government Unit, to create software and update the local finance information technology systems to allow XBRL files to be used for financial disclosure by local unit of government as a substitute for the current financial reporting forms. (Sec. 949r)
14. **Compulsive Gaming Prevention Fund and Millionaire Party Oversight.** The **Governor** modified the language for the Compulsive Gaming Prevention Fund deposits and Millionaire Party Oversight to reflect the change of the fund source for Millionaire Party regulations to Internet Gaming Revenue and removed the report. The **Senate** did not include. (Secs. 971 and 979)
15. **Internet Gaming Revenue Deposits (NEW).** The **Governor/Senate** included new language that requires that revenue generated from Fantasy Contests Gaming, Lawful Internet Gaming, and Lawful Sports Betting be transferred in accordance with statute and that any remaining funds be deposited into the School Aid Act Fund. (Sec. 972)
16. **Native American Gaming Compacts.** The **Governor** modified the language for Native American Gaming Compacts to remove the report on local revenue sharing distributions. The **Senate** maintained current language. (Sec. 973)
17. **Horse Racing Regulations.** The **Governor** removed the language regarding horsemen organizations' funding of the horsing regulatory costs. The **Senate** maintained current language. (Sec. 978)
18. **Electric Vehicle Rebate Program (NEW).** The **Governor** included new language that would implement a rebate program for electric vehicle purchases and \$10.0 million for purchases of at-home charging equipment. The **Senate** did not include. (Sec. 1200)
19. **Local Community Transition Support Program (NEW).** The **Governor** included new language that creates a local community transition grant program, outlines grant eligibility, the use of funds, allows up to 3% of the appropriation to be used for administration, and requires a report by September 30, 2023. The **Senate** did not include. (Sec. 1201)
20. **Retirement Income Tax Reform Implementation (NEW).** The **Governor** included new language that requires that the appropriation for Retirement Income Tax Reform Implementation be used to support implementation cost if section 30 of the Income Tax Act is amended. Designates unexpended funds as a work project with a completion date of September 30, 2027. The **Senate** did not include. (Sec. 1202)
21. **Technical Changes.** The **Governor/Senate** made a number of technical modifications that include date changes, Part 1 appropriation changes, legacy cost adjustments, and standardized language. (Secs. 210 and 214)
