SUBSTITUTE FOR HOUSE BILL NO. 4302

A bill to amend 1987 PA 96, entitled "The mobile home commission act,"

(MCL 125.2301 to 125.2350) by adding section 28d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 28d. (1) An owner of a mobile home park or seasonal
- 2 mobile home park shall offer a lease or rental agreement with a
- 3 term of no less than 1 year to a prospective tenant or tenant.
- 4 However, nothing in this subsection prohibits an owner of a mobile
- 5 home park or seasonal mobile home park from entering into a monthly
- 6 lease or rental agreement with a prospective tenant or tenant.
- 7 (2) Not less than 30 days before a lease or a rental agreement
- 8 with a duration of 1 year or greater expires, the owner of a mobile
- 9 home park or seasonal mobile home park shall deliver to the tenant

- 1 a written or electronic notice identifying the date the lease or
- 2 rental agreement ends and offering a renewal of the lease or a new
- 3 lease or rental agreement. Any expired lease or rental agreement
- 4 not renewed in writing constitutes a month-to-month tenancy with
- 5 all the rights, responsibilities, and obligations of a month-to-
- 6 month tenancy.
- 7 (3) A lease or rental agreement between an owner of a mobile
- 8 home park or seasonal mobile home park and a tenant for a duration
- 9 that is less than 1 year must include language that a lease or
- 10 rental agreement of a duration of 1 year or more was offered but
- 11 was declined.
- 12 (4) A lease or rental agreement between an owner of a mobile
- 13 home park or seasonal mobile home park and a tenant must include
- 14 language that an unlicensed owner of a mobile home park or seasonal
- 15 mobile home park shall not collect rent or take any action for
- 16 possession against residents pursuant to section 16.
- 17 (5) A lease or rental agreement under this act must comply
- 18 with the truth in renting act, 1978 PA 454, MCL 554.631 to 554.641.
- 19 A person that violates this subsection is liable as provided in
- 20 section 42.
- 21 (6) A tenant of a mobile home park or seasonal mobile home
- 22 park may bring an action on his or her own behalf for a violation
- 23 of this section in a court of competent jurisdiction.
- 24 Enacting section 1. This amendatory act does not take effect
