by amending sections 2253 and 2453 (MCL 333.2253 and 333.2453), section 2253 as amended by 2006 PA 157.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2253. (1) If Except as otherwise provided in subsection
- 2 (4), if the director determines that control of an epidemic is
- 3 necessary to protect the public health, the director by emergency
- 4 order may prohibit the gathering of people for any purpose and may

- 1 establish procedures to be followed during the epidemic to insure
- 2 ensure continuation of essential public health services and
- ${f 3}$ enforcement of health laws. Emergency procedures ${f shall}$ are not ${f be}$
- 4 limited to this code.

- 26 be followed by persons, including a local governmental entity,
- 27 during the epidemic to insure ensure continuation of essential
- 28 public health services and enforcement of health laws. Emergency
- 29 procedures shall are not be limited to this code.
