THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 234d. (1) Except as provided in subsection (2), a person
- 2 shall not possess a firearm on the premises of any of the
- 3 following:
- 4 (a) A depository financial institution or a subsidiary or
- 5 affiliate of a depository financial institution.

- 1 (b) A church or other house of religious worship.
- 2 (c) A court.
- 3 (d) A theatre.
- 4 (e) A sports arena.
- 5 (f) A day care center.
- 6 (g) A hospital.
- 7 (h) An establishment licensed under the Michigan liquor

- 28 (4) Subsection (3) does not apply to any of the following:
