

HOUSE BILL NO. 4141

February 04, 2021, Introduced by Reps. Bolden and Filler and referred to the Committee on Judiciary.

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
by amending section 801e (MCL 257.801e), as amended by 1983 PA 91.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 801e. (1) ~~When~~**If** a moped required to be registered under
2 this act is sold by a retailer to a general purchaser, the **retailer**
3 **shall obtain the** certificate of registration ~~shall be obtained in~~
4 the name of the purchaser. ~~by the retailer.~~In other cases,
5 **circumstances, the purchaser shall obtain** the certificate of

1 registration. ~~shall be obtained by the purchaser. The~~ **An**
2 application ~~shall~~ **for registration must** be signed by the purchaser
3 of the moped and ~~shall be accompanied by a fee of \$15.00. Upon~~
4 receipt of the ~~an~~ application **for registration** in approved form,
5 the secretary of state shall enter the application upon the
6 secretary of state's records and issue to the applicant a
7 certificate of registration containing the decal for the moped, the
8 name and address of the owner, and other information the secretary
9 of state considers necessary. A moped ~~shall-is~~ not ~~be~~ required to
10 be insured ~~in the manner specified for motor vehicles under chapter~~
11 ~~31 of Act No. 218 of the Public Acts of 1956, as amended, being~~
12 ~~sections 500.3101 to 500.3179 of the Michigan Compiled Laws. under~~
13 **chapter 31 of the insurance code of 1956, 1956 PA 218, MCL 500.3101**
14 **to 500.3179.** The certificate of registration ~~shall~~ **must** be pocket
15 size, ~~shall~~ accompany the vehicle, ~~shall be~~ legible, and ~~shall be~~
16 made available for inspection upon demand by a law enforcement
17 officer.

18 (2) ~~A~~ **The secretary of state shall issue a** decal indicating
19 that the certificate of registration is in ~~full force and effect.~~
20 ~~shall be issued.~~ A registration certificate and decal ~~shall~~ **must**
21 not be issued earlier than 90 days preceding the commencement date
22 of the new registration period. Display of the decal ~~shall~~ **must** be
23 as prescribed by rule promulgated by the secretary of state.

24 (3) A retailer or manufacturer of mopeds, upon application to
25 the secretary of state upon forms provided by the secretary of
26 state, may obtain certificates of registration for use in the
27 testing or demonstrating of a moped upon payment of \$10.00 for each
28 of the first 2 registration certificates. Additional certificates
29 may be issued at a cost of \$5.00 each and used by the applicant

1 only in the testing or demonstrating of mopeds by temporary
2 placement of the registration on the moped being tested or
3 demonstrated. A certificate issued ~~pursuant to~~**under** this
4 subsection may be used on only 1 moped at ~~any given a~~ time.

5 (4) A moped registration ~~shall be~~**is** valid for a 3-year period
6 ~~which that~~ begins on May 1 and expires on April 30 of the third
7 registration year. For purposes of this subsection, a registration
8 year begins on May 1 and ends on April 30.

9 (5) **A person who violates this section is responsible for a**
10 **civil infraction.**

13 01303'21) of the 101st Legislature is enacted into law.
