- 1 Sec. 1162. (1) Subject to subsections (2), (3), and (5),
- 2 beginning with the 2021-2022 school year, the board of a school
- 3 district or board of directors of a public school academy shall
- 4 employ a certified library media specialist for each school library
- 5 operated by the school district or public school academy as

- 2 (a) For a school with less than 300 pupils, at least 1 half-

- 4 (b) For a school with 300 to 1,499 pupils, at least 1 full-

- 7 time certified library media specialists.
- 8 (2) The board of a school district or board of directors of a
- 9 public school academy that has less than 51 pupils enrolled in the

- (ii) Until 2024, a certificated teacher under section 1531 who is in the process of obtaining an ND library media endorsement issued by the department.
