## **HOUSE BILL NO. 4690**

April 21, 2021, Introduced by Reps. Kahle and Fink and referred to the Committee on Elections and Ethics.

A bill to amend 1978 PA 472, entitled

"An act to regulate political activity; to regulate lobbyists, lobbyist agents, and lobbying activities; to require registration of lobbyists and lobbyist agents; to require the filing of reports; to prescribe the powers and duties of the department of state; to prescribe penalties; and to repeal certain acts and parts of acts,"

by amending section 5 (MCL 4.415), as amended by 1986 PA 83.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5. (1) "Governmental body" means a state legislative or
- 2 governing body, including a board, commission, committee,
- 3 subcommittee, authority, or council, that may, under a state

- 1 constitution, statute, or rule, exercise governmental or
- 2 proprietary authority or perform a governmental or proprietary
- 3 function, or a lessee of the body that performs an essential public
- 4 purpose and function under the lease agreement.
- 5 (2) "Influencing" means promoting, supporting, affecting,
- 6 modifying, opposing, or delaying, by any means, including the
- 7 providing of or use of information, statistics, studies, or
- 8 analysis.
- 9 (3) (1)—"Legislative action" means introduction, sponsorship,
- 10 support, opposition, consideration, debate, vote, passage, defeat,
- 11 approval, veto, delay, or an official action by an official in the
- 12 executive branch or an official in the legislative branch on a
- 13 bill, resolution, amendment, nomination, appointment, report, or
- 14 any matter pending or proposed in a legislative committee or either
- 15 house of the legislature. Legislative action does not include the
- 16 representation of a person who has been subpoenaed to appear before
- 17 the legislature or an agency of the legislature.
- 18 (4) (2) "Lobbying" means communicating directly with an
- 19 official in the executive branch of state government or an official
- 20 in the legislative branch of state government for the purpose of
- 21 influencing legislative action or administrative action. Lobbying
- 22 does not include the providing of technical information by a person
- 23 other than a person as defined in subsection (5) lobbyist agent or
- 24 an employee of a person as defined in subsection (5) lobbyist agent
- 25 when appearing before an officially convened legislative committee
- 26 or executive department hearing panel. As used in this subsection,
- 27 "technical information" means empirically verifiable data provided
- 28 by a person recognized as an expert in the subject area to which
- 29 the information provided is related.

(5) (4) "Lobbyist" means any of the following:

- 6 (a) A person whose expenditures for lobbying are more than7 \$1,000.00 in value in any 12-month period.
- 8 (b) A person whose expenditures for lobbying are more than
  9 \$250.00 in value in any 12-month period, if the amount is expended
  10 on lobbying a single public official.
- 11 (c) For the purpose of subdivisions (a) and (b), groups of 25
  12 or more people shall not have their personal expenditures for food,
  13 travel, and beverage included , providing if those expenditures are
  14 not reimbursed by a lobbyist or lobbyist agent.
- (d) The state or a political subdivision which that contractsfor a lobbyist agent.
- 17 (6) (5)—"Lobbyist agent" means a person who receives
  18 compensation or reimbursement of actual expenses, or both, in a
  19 combined amount in excess of \$250.00 in any 12-month period for
  20 lobbying.

- 23 (a) An employee of the lobbyist or lobbyist agent.
  - (b) For purposes of section 8(1)(b)(i) and 9(1)(b), a member of the lobbyist or employee of a member of the lobbyist, when the lobbyist is a membership organization or association, and when the lobbyist agent or an employee of the lobbyist or lobbyist agent is present during any part of the period during which the purchased food or beverage is consumed.

- 4 (7) Lobbyist or lobbyist agent does not include any of the following:
- 6 (a) A publisher, owner, or working member of the press, radio,
  7 or television while disseminating news or editorial comment to the
  8 general public in the ordinary course of business.
- 9 (b) All elected or appointed public officials of state or
  10 local government who are acting in the course or scope of the
  11 office for no compensation, other than that provided by law for the
  12 office, -not including any of the following:
- 13 (c) For the purposes of this act, subdivision (b) shall not

- (i) Employees of public or private colleges, communitycolleges, junior colleges, or universities.

- (8) "Mass mailing" means not less than 1,000 pieces ofsubstantially similar material mailed within a 7-day period.
- (9) "Official in the executive branch" means the governor,
  lieutenant governor, secretary of state, attorney general; or an
  individual who is in the executive branch of state government and

- 1 not under civil service; or a classified director, chief deputy
- 2 director, or deputy director of a state department. This Official
- 3 in the executive branch includes an individual who is elected or
- 4 appointed and has not yet taken, or an individual who is nominated
- 5 for appointment to, any of the offices or agencies enumerated in
- 6 this subsection. An official Official in the executive branch does
- 7 not include a person an individual serving in a clerical,
- 8 nonpolicy-making, or nonadministrative capacity. In addition to all
- 9 of the foregoing, an official Official in the executive branch
- 10 includes, but is not limited to, all of the following:

- - (10) "Official in the legislative branch" means a member of the legislature, the auditor general, the deputy auditor general, an employee of the consumer's council, the director of the legislative retirement system, a policy director or advisor for the minority or majority political party, a budget director or advisor for the minority or majority political party, an employee assigned to a legislator's office, or any other employee of the legislature other than an individual employed by the state in a clerical or nonpolicy-making capacity.
    - (11) "Governmental body" means any state legislative or governing body, including a board, commission, committee, subcommittee, authority, or council, which is empowered by state constitution, statute, or rule to exercise governmental or proprietary authority or perform a governmental or proprietary function, or a lessee thereof performing an essential public purpose and function under the lease agreement.
    - (11) "Representative of the lobbyist" means any of the following:
      - (a) An employee of a lobbyist or lobbyist agent.
- 27 (b) For purposes of sections 8(1)(b)(i) and 9(1)(b), a member 28 of a lobbyist or employee of a member of a lobbyist if the lobbyist 29 is a membership organization or association and the lobbyist agent

- 1 or an employee of the lobbyist or lobbyist agent is present during
- 2 any part of the period during which the purchased food or beverage
- 3 is consumed.
- 4 (c) A person that is reimbursed by the lobbyist or lobbyist
- 5 agent for an expenditure, other than an expenditure for food or
- 6 beverage, that was incurred for the purpose of lobbying.
- 7 Enacting section 1. This amendatory act takes effect January
- **8** 1, 2022.
