A bill to amend 1937 PA 94, entitled "Use tax act,"

by amending sections 2 and 21 (MCL 205.92 and 205.111), section 2 as amended by 2018 PA 1 and section 21 as amended by 2020 PA 30.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Person" means an individual, firm, partnership, joint
- 3 venture, association, social club, fraternal organization,
- 4 municipal or private corporation whether or not organized for

- 1 profit, company, limited liability company, estate, trust,
- 2 receiver, trustee, syndicate, the United States, this state,
- 3 county, or any other group or combination acting as a unit, and the
- 4 plural as well as the singular number, unless the intention to give
- 5 a more limited meaning is disclosed by the context.
- **6** (b) "Use" means the exercise of a right or power over tangible
- 7 personal property incident to the ownership of that property
- 8 including transfer of the property in a transaction where
- 9 possession is given. Converting tangible personal property acquired
- 10 for a use exempt from the tax levied under this act to a use not
- 11 exempt from the tax levied under this act is a taxable use.
- 12 (c) "Storage" means a keeping or retention of property in this
- 13 state for any purpose after the property loses its interstate
- 14 character.
- (d) "Seller" means the person from whom a purchase is made and
- 16 includes every person selling tangible personal property or
- 17 services for storage, use, or other consumption in this state. If,
- 18 in the opinion of the department, it is necessary for the efficient
- 19 administration of this act to regard a salesperson, representative,
- 20 peddler, or canvasser as the agent of a dealer, distributor,
- 21 supervisor, or employer under whom the person operates or from whom
- 22 he or she the person obtains tangible personal property or services
- 23 sold by him or her the person for storage, use, or other
- 24 consumption in this state, irrespective of whether or not he or she
- 25 the person is making the sales on his or her the person's own
- 26 behalf or on behalf of the dealer, distributor, supervisor, or
- 27 employer, the department may so consider him or her, the person,
- 28 and may consider the dealer, distributor, supervisor, or employer
- 29 as the seller for the purpose of this act.

(e) "Purchase" means to acquire for a consideration, whether

- 2 the acquisition is effected by a transfer of title, of possession,
 3 or of both, or a license to use or consume; whether the transfer is
 4 absolute or conditional, and by whatever means the transfer is
 5 effected; and whether consideration is a price or rental in money,
- 6 or by way of exchange or barter. Purchase includes converting
- 7 tangible personal property acquired for a use exempt from the tax
- 8 levied under this act to a use not exempt from the tax levied under
- 9 this act.

- 10 (f) "Purchase price" or "price" means the total amount of
 11 consideration paid by the consumer to the seller, including cash,
 12 credit, property, and services, for which tangible personal
 13 property or services are sold, leased, or rented, valued in money,
 14 whether received in money or otherwise, and applies to the measure
- 15 subject to use tax. Purchase price includes the following
- 16 subparagraphs (i) through to (vii) and excludes subparagraphs (viii)
- 17 $\frac{\text{through }(xiv):}{\text{to }(xv):}$
- 18 (i) Seller's cost of the property sold.
- 19 (ii) Cost of materials used, labor or service cost, interest,
 20 losses, costs of transportation to the seller, taxes imposed on the
 21 seller other than taxes imposed by this act, and any other expense
 22 of the seller.
- 23 (iii) Charges by the seller for any services necessary to
 24 complete the sale, other than the following:
- 25 (A) An amount received or billed by the taxpayer for
 26 remittance to the employee as a gratuity or tip, if the gratuity or
 27 tip is separately identified and itemized on the guest check or
 28 billed to the customer.
- 29 (B) Labor or service charges involved in maintenance and

- repair work on tangible personal property of others if separatelyitemized.
- $\bf 3$ (iv) Delivery charges incurred or to be incurred before the
- 4 completion of the transfer of ownership of tangible personal
- 5 property subject to the tax levied under this act from the seller
- 6 to the purchaser.
- 7 (v) Installation charges incurred or to be incurred before the
- 8 completion of the transfer of ownership of tangible personal
- 9 property from the seller to the purchaser.
- 10 (vi) Except as otherwise provided in subparagraphs (xi), (xii),
- 11 and (xiv), credit for any trade-in.
- 12 (vii) Except as otherwise provided in subparagraph (x) or (xv),
- 13 consideration received by the seller from third parties if all of
- 14 the following conditions are met:
- 15 (A) The seller actually receives consideration from a party
- 16 other than the purchaser and the consideration is directly related
- 17 to a price reduction or discount on the sale.
- 18 (B) The seller has an obligation to pass the price reduction
- 19 or discount through to the purchaser.
- 20 (C) The amount of the consideration attributable to the sale
- 21 is fixed and determinable by the seller at the time of the sale of
- 22 the item to the purchaser.
- (D) One of the following criteria is met:
- 24 (I) The purchaser presents a coupon, certificate, or other
- 25 documentation to the seller to claim a price reduction or discount
- 26 where the coupon, certificate, or documentation is authorized,
- 27 distributed, or granted by a third party with the understanding
- 28 that the third party will reimburse any seller to whom the coupon,
- 29 certificate, or documentation is presented.

- 1 (II) The purchaser identifies himself or herself to the seller
- 2 as a member of a group or organization entitled to a price
- 3 reduction or discount. A preferred customer card that is available
- 4 to any patron does not constitute membership in a group or
- 5 organization.
- 6 (III) The price reduction or discount is identified as a third
- 7 party price reduction or discount on the invoice received by the
- 8 purchaser or on a coupon, certificate, or other documentation
- 9 presented by the purchaser.
- 10 (viii) Interest, financing, or carrying charges from credit
- 11 extended on the sale of personal property or services, if the
- 12 amount is separately stated on the invoice, bill of sale, or
- 13 similar document given to the purchaser.
- 14 (ix) Any taxes legally imposed directly on the consumer that
- 15 are separately stated on the invoice, bill of sale, or similar
- 16 document given to the purchaser.
- 17 (x) Beginning January 1, 2000, employee discounts that are
- 18 reimbursed by a third party on sales of motor vehicles.
- 19 (xi) Beginning November 15, 2013, credit for the agreed-upon
- 20 value of a titled watercraft used as part payment of the purchase
- 21 price of a new titled watercraft or used titled watercraft
- 22 purchased from a watercraft dealer if the agreed-upon value is
- 23 separately stated on the invoice, bill of sale, or similar document
- 24 given to the purchaser. This subparagraph does not apply to leases
- 25 or rentals.
- 26 (xii) Beginning December 15, 2013, credit for the agreed-upon
- 27 value of a motor vehicle or recreational vehicle used as part
- 28 payment of the purchase price of a new motor vehicle or used motor
- 29 vehicle or recreational vehicle purchased from a dealer if the

- 1 agreed-upon value is separately stated on the invoice, bill of
- 2 sale, or similar document given to the purchaser. This subparagraph
- 3 does not apply to leases or rentals. Except as otherwise provided
- 4 under subparagraph (xiv), for purposes of this subparagraph, the
- 5 agreed-upon value of a motor vehicle or recreational vehicle used
- 6 as part payment shall be is limited as follows:
- 7 (A) Beginning December 15, 2013, subject to sub-subparagraphs
- 8 (B) and (C), the lesser of the following:
- 9 (I) \$2,000.00.
- 10 (II) The agreed-upon value of the motor vehicle or
- 11 recreational vehicle used as part payment.
- 12 (B) Beginning January 1, 2015 and each January 1 thereafter
- 13 through December 31, 2018, the amount under sub-subparagraph (A)(I)
- 14 shall be is increased by an additional \$500.00 each year.
- 15 (C) Beginning January 1, 2019, subject to sub-subparagraphs
- 16 (D) and (E), the lesser of the following:
- 17 (I) \$5,000.00.
- 18 (II) The agreed-upon value of the motor vehicle used as part
- 19 payment.
- 20 (D) Beginning January 1, 2020 and each January 1 thereafter,
- 21 the amount under sub-subparagraph (C)(I) shall be is increased by
- 22 an additional \$1,000.00 each year.
- 23 (E) Beginning on January 1, in the year in which the amount
- 24 under sub-subparagraph (C)(I) exceeds \$14,000.00 and each January 1
- 25 thereafter, there shall be is no limitation on the agreed-upon
- 26 value of the motor vehicle used as part payment.
- (xiii) Beginning January 1, 2017, credit for the core charge
- 28 attributable to a recycling fee, deposit, or disposal fee for a
- 29 motor vehicle or recreational vehicle part or battery if the

- 1 recycling fee, deposit, or disposal fee is separately stated on the
- 2 invoice, bill of sale, or similar document given to the purchaser.
- 3 (xiv) Beginning January 1, 2018, credit for the agreed-upon
- 4 value of a recreational vehicle used as part payment of the
- 5 purchase price of a recreational vehicle purchased from a dealer if
- 6 the agreed-upon value is separately stated on the invoice, bill of
- 7 sale, or similar document given to the purchaser. This subparagraph
- 8 does not apply to leases or rentals.
- 9 (xv) Beginning on January 1, 2022, manufacturer rebates on
- 10 motor vehicles.
- 11 (g) "Consumer" means the person who has purchased tangible
- 12 personal property or services for storage, use, or other
- 13 consumption in this state and includes, but is not limited to, 1 or
- 14 more of the following:
- 15 (i) A person acquiring tangible personal property if engaged in
- 16 the business of constructing, altering, repairing, or improving the
- 17 real estate of others.
- 18 (ii) A person who has converted tangible personal property or
- 19 services acquired for storage, use, or consumption in this state
- 20 that is exempt from the tax levied under this act to storage, use,
- 21 or consumption in this state that is not exempt from the tax levied
- 22 under this act.
- 23 (h) "Business" means all activities engaged in by a person or
- 24 caused to be engaged in by a person with the object of gain,
- 25 benefit, or advantage, either direct or indirect.
- 26 (i) "Department" means the department of treasury.
- 27 (j) "Tax" includes all taxes, interest, or penalties levied
- 28 under this act.
- 29 (k) "Tangible personal property" means personal property that

- 1 can be seen, weighed, measured, felt, or touched or that is in any
- 2 other manner perceptible to the senses and includes electricity,
- 3 water, gas, steam, and prewritten computer software.
- 4 (1) "Textiles" means goods that are made of or incorporate
- 5 woven or nonwoven fabric, including, but not limited to, clothing,
- 6 shoes, hats, gloves, handkerchiefs, curtains, towels, sheets,
- 7 pillows, pillowcases, tablecloths, napkins, aprons, linens, floor
- 8 mops, floor mats, and thread. Textiles also include materials used
- 9 to repair or construct textiles, or other goods used in the rental,
- 10 sale, or cleaning of textiles.

- (n) "Qualified commercial motor vehicle" means that term as

- 19 of the motor fuel tax act, 2000 PA 403, MCL 207.1002.

- 21 property or services are purchased or rented for storage, use, or
- 22 other consumption in this state.
- 23 (q) "Convert" means putting a service or tangible personal
- 24 property acquired for a use exempt from the tax levied under this
- 25 act at the time of acquisition to a use that is not exempt from the
- 26 tax levied under this act, whether the use is in whole or in part,
- 27 or permanent or not permanent. A motor vehicle purchased for resale
- 28 by a new vehicle dealer licensed under section 248(8)(a) of the
- 29 Michigan vehicle code, 1949 PA 300, MCL 257.248, and not titled in

- the name of the dealer shall is not be considered to be converted
 prior to before sale or lease by that dealer.
- 3 (r) "New motor vehicle" means that term as defined in section4 33a of the Michigan vehicle code, 1949 PA 300, MCL 257.33a.
- (s) "Recreational vehicle" means that term as defined insection 49a of the Michigan vehicle code, 1949 PA 300, MCL 257.49a.
- 7 (t) "Dealer" means that term as defined in section 11 of the 8 Michigan vehicle code, 1949 PA 300, MCL 257.11.
- 9 (u) "Watercraft dealer" means a dealer as that term is defined 10 in section 80102 of the natural resources and environmental 11 protection act, 1994 PA 451, MCL 324.80102.
- Sec. 21. (1) Except as **otherwise** provided in subsections (2),

 13 (3), (4), and (5), **this section**, all money received and collected

 14 under this act must be deposited by the department of treasury in

 15 the state treasury to the credit of the general fund, to be

 16 disbursed only by appropriations by the legislature.
- 17 (2) The collections from the use tax imposed at the additional 18 rate of 2% approved by the electors on March 15, 1994 must be 19 deposited in the state school aid fund. established in section 11 20 of article IX of the state constitution of 1963.

- (3) From In addition to the money deposited in the state school aid fund under subsection (2), from the money received and collected under this act for the state share, an amount equal to all—the sum of the following, as determined by the department, must be deposited into the state school aid fund:

 27 PA 331, MCL 211.901 to 211.906, all as a result of the exemption of
 28 personal property under sections 9m, 9n, and 9o of the general

- (c) All revenue lost to the school aid fund as a result of the exemption under section 4cc. , as determined by the department, must be deposited into the state school aid fund established by section 11 of article IX of the state constitution of 1963. Funds deposited into the state school aid fund under this subsection must not include the portion of the state share of the use tax imposed at the additional rate of 2% approved by the electors of this state on March 15, 1994 and dedicated for aid to schools under subsection (2). A person that claims an exemption under section 4cc shall report the purchase price of the data center equipment as defined in section 4cc and any other information necessary to determine the amount of revenue lost to the school aid fund as a result of the exemption under section 4cc annually on a form at the time and in a manner prescribed by the department. The
- (d) All revenue lost to the state school aid fund as a result of the exclusion under section 2(f)(xv). A person that excludes a manufacturer rebate from the purchase price of a motor vehicle under section 2(f)(xv) for purposes of calculating the tax due under this act shall report the amount of the manufacturer rebate and any other information necessary to determine the amount of revenue lost to the school aid fund as a result of the exclusion under section 2(f)(xv) on a form at the time and in a manner prescribed by the department.
- (4) A report required under this subsection shall (3) must not
