## **HOUSE BILL NO. 5426**

October 20, 2021, Introduced by Reps. Tisdel and Witwer and referred to the Committee on Commerce and Tourism.

A bill to amend 1984 PA 270, entitled "Michigan strategic fund act,"

by amending section 9 (MCL 125.2009), as amended by 2017 PA 109, and by adding chapter 8F.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 9. (1) The fund shall transmit to each member of the
- 2 legislature, the governor, the clerk of the house of
- 3 representatives, the secretary of the senate, and the senate and
- 4 house fiscal agencies annually a report of its activities. The
- 5 report shall be transmitted not later than April 10 of each year

- 1 for activities in the immediately preceding state fiscal year. The
- 2 report shall not include information exempt from disclosure under
- 3 section 5. The report shall include, but is not limited to, all of
- 4 the following for each program operated under this act:
- 5 (a) A list of entities that received financial assistance.
- **6** (b) The type of project or product being financed.
- 7 (c) The amount and type of financial assistance.
- 8 (d) For each separate form of financial assistance, all of the
- 9 following:
- (i) The number of new jobs committed or projected when the
- 11 financial assistance was applied for.
- 12 (ii) The number of retained jobs committed or projected when
- 13 the financial assistance was applied for.
- 14 (iii) The actual number of new jobs created that are not
- 15 temporary employees.
- (iv) The actual number of retained jobs that are not temporary
- 17 employees.
- 18 (v) The average annual salary of the new jobs created that are
- 19 not temporary employees.
- (vi) The average annual salary of the retained jobs that are
- 21 not temporary employees.
- (e) The duration of the financial assistance.
- 23 (f) The amount of financial support other than state
- 24 resources.
- 25 (g) Money or other revenue or property returned to the fund,
- 26 including any repayments through a clawback provision in the
- 27 agreement.
- 28 (h) The status of all loans of the fund.
- 29 (i) A list of all entities that are in bankruptcy, that the

- 1 fund has received actual notice of, filed by a direct recipient of
- 2 an active single incentive of at least \$500,000.00. In addition,
- 3 the fund shall, within 120 days after the fund receives notice,
- 4 provide a report of the notice of bankruptcy on its website and
- 5 shall forward the report to each of the following:
- 6 (i) The senate majority leader and the senate minority leader.
- 7 (ii) The speaker of the house and the house minority leader.
- 8 (iii) The members of the house commerce committee.

  - (j) A summary of the approximate administrative costs used to administer the programs and activities authorized under this act.
    - (k) Any other information as required in this section.
  - (2) The auditor general or a certified public accountant appointed by the auditor general annually shall conduct and remit to the legislature an audit of the fund and, in the conduct of the audit, shall have access to all records of the fund at any time, whether or not confidential. Each audit required by this section shall include a determination of whether the fund is likely to be able to continue to meet its obligations, including a report on the status of outstanding loans and agreements made by the fund.
  - (3) The fund shall also transmit the audit described in subsection (2) to the chairperson and minority vice-chairperson of the senate appropriations subcommittee on general government and the house of representatives appropriations subcommittee on general government. The fund shall make the report and audit available to

- 9 (ii) The return on investment analysis that utilizes existing 10 baseline data and compares results with prior outcome evaluations 11 funded by Travel Michigan.
  - (b) For business development efforts, all of the following:
  - (i) An itemized list, by market, of how much was spent, types of media purchased, and target of the business promotion campaign.
- (ii) A performance analysis that compares the program orcampaign objectives and outcome of the campaign or program.

- (a) The total actual amount of private investment attractedunder section 90d as reported to the fund.
- (b) The actual amount of the community revitalizationincentives made under chapter 8C separately for each project.
- 24 (c) The total actual amount of square footage revitalized or 25 added for each project approved under section 90d as reported to 26 the fund. When reporting square footage, the person must report the 27 square footage by category, including, but not limited to, 28 commercial, residential, or retail.
- 29 (d) The aggregate increase in taxable value of all property

- 1 subject to a written agreement under chapter 8C when established
- 2 and recorded by the local units of government and as reported to
- 3 the fund.
- 4 (e) The total actual number of residential units revitalized
- 5 or added for each project approved under section 90d as reported to
- 6 the fund.
- 7 (f) Each project that received a community revitalization

- 26 immediately preceding fiscal year.
- 27 (13) Beginning on July 1, 2015, the fund shall post and update
- 28 periodically all of the following on its website for all loans made
- 29 under sections 88r and 90b:

- 1 (a) A description of the project for which the loan was made.
- 2 (b) The total amount of the loan.
- 3 (c) Whether payments on the loan balance are current or4 delinquent.
- 5 (d) The interest rate of the loan.
- 6 (14) Beginning July 1, 2015, the report described in
  7 subsection (1) shall also contain all of the following for each
  8 program that provides financial assistance under this act that
- 9 requires a site visit:

- (a) A copy of the site visit guidelines for that program.
- 11 (b) The number of site visits conducted under that program.
- (c) The chief compliance officer shall review and evaluatecompliance with the site visit quidelines.
- 14 (15) The fund shall post on its website and update15 periodically all of the information described in subsection (14).
- 16 (16) The report described in subsection (1) must also include,
  17 but is not limited to, all of the following for all written
  18 agreements related to the good jobs for Michigan program created
  19 under chapter 8D and the Michigan employment opportunity program
  20 created under chapter 8F:

- (b) The number of certified new jobs required to be

- (c) The amount and duration of the withholding tax capture

  grants, loans, other economic assistance, and any other incentives

- 1 Sec. 90t. As used in this chapter:
- 2 (a) "Authorized business" means an eligible business that has
- 3 met the requirements of this chapter and with which the fund has
- 4 entered into a written agreement for withholding tax capture
- 5 revenues pursuant to this chapter and section 51f of the income tax
- 6 act of 1967, 1967 PA 281, MCL 206.51f.
- 7 (b) "Casino" means a casino regulated by this state under the
- 8 Michigan Gaming Control and Revenue Act, 1996 IL 1, MCL 432.201 to

- 10 gaming regulatory act, Public Law 100-497, 102 Stat 2467, or

- 14 (c) "Certified new job" means a full-time job created by an
- 15 authorized business at a facility in this state that is in excess

- 18 full-time jobs that the authorized business acquired through a
- 19 merger or acquisition that were located in this state prior to the
- 20 expansion or location, as determined by the fund. Pursuant to a
- 21 written agreement between the authorized business, the fund, and
- 22 the primary supplier, certified new jobs for an authorized business
- 23 described in subdivision (d) (i) may, as determined by the fund,
- 24 include the number of those new jobs created by the primary
- 25 supplier of that authorized business as a result of the new or
- 26 increased business activity with that authorized business as
- 27 determined by the fund.
- 28 (d) "Eligible business" means a business other than a retail
- 29 establishment, professional sports stadium, casino, or that portion

- 1 of an eligible business used exclusively for retail sales that
- 2 proposes to create 1 or more of the following:
- 3 (i) For an eligible business located in a tier 1 county, 1 of
- 4 the following:
- 5 (A) A minimum of 3,000 certified new jobs in this state with
- 6 an average annual wage that is equal to or greater than the
- 7 prosperity region average wage.
- 8 (B) A minimum of 500 certified new jobs in this state with an
- 9 average annual wage that is equal to or greater than the prosperity
- 10 region average wage.
- 11 (C) A minimum of 250 certified new jobs in this state with an
- 12 average annual wage that is equal to 125% or more of the prosperity
- 13 region average wage.
- 14 (ii) For an eligible business located in a tier 2 county, 1 of
- 15 the following:
- 16 (A) A minimum of 500 certified new jobs in this state with an
- 17 average annual wage that is equal to or greater than the prosperity
- 18 region average wage.
- 19 (B) A minimum of 250 certified new jobs in this state with an
- 20 average annual wage that is equal to or greater than the prosperity
- 21 region average wage.
- 22 (C) A minimum of 100 certified new jobs in this state with an
- 23 average annual wage that is equal to 125% or more of the prosperity
- 24 region average wage.
- 25 (iii) For an eligible business located in a tier 3 county, 1 of
- 26 the following:
- 27 (A) A minimum of 250 certified new jobs in this state with an
- 28 average annual wage that is equal to or greater than the prosperity
- 29 region average wage.

- 1 (B) A minimum of 100 certified new jobs in this state with an 2 average annual wage that is equal to or greater than the prosperity 3 region average wage.
- 4 (C) A minimum of 50 certified new jobs in this state with an average annual wage that is equal to 125% or more of the prosperity region average wage.
- 7 (e) "Employment opportunity fund" means the employment 8 opportunity fund created in section 90w.
- 9 (f) "Facility" means a site or sites within this state in 10 which an authorized business creates certified new jobs.
- 11 (g) "Full-time job" means a full-time job as determined by the 12 fund performed by an individual whose income and Social Security 13 taxes are withheld by 1 or more of the following:
- 14 (i) An authorized business.
- 15 (ii) An employee leasing company.
- 16 (iii) A professional employer organization on behalf of the 17 authorized business.
- 18 (h) "Municipality" means that term as defined in section 4.
- (i) "Primary supplier" means an entity that creates not fewer than 25 new jobs in this state and that provides both of the following to an authorized business pursuant to a written agreement under this chapter:
- 23 (i) A minimum of \$5,000,000.00 in tangible personal property
  24 annually as determined by the fund.
- 25 (ii) A minimum of 10% of the tangible personal property used by the authorized business annually as determined by the fund.
- 27 (j) "Prosperity region" means each of the 10 prosperity
  28 regions identified by the department of technology, management, and
  29 budget on the effective date of the amendatory act that added this

- 1 section.
- 2 (k) "Prosperity region average wage" means the average annual
- 3 wage for the prosperity region where the facility is located based
- 4 on the most recent data made available by the Michigan bureau of
- 5 labor market information and strategic initiatives.
- 6 (l) "Tier 1 county" means a county with a population of 250,000
- 7 or more.
- 8 (m) "Tier 2 county" means a county with a population of more
- 9 than 90,000 and less than 250,000.
- 10 (n) "Tier 3 county" means a county with a population of 90,000
- 11 or less.
- 12 (o) "Withholding tax capture revenues" means the amount of
- 13 income tax withheld under part 3 of the income tax act of 1967,
- 14 1967 PA 281, MCL 206.701 to 206.713, each calendar year that is
- 15 attributable to individuals employed within certified new jobs. The
- 16 state treasurer shall develop methods and processes that are
- 17 necessary for each authorized business to report the amount of
- 18 withholding under part 3 of the income tax act of 1967, 1967 PA
- 19 281, MCL 206.701 to 206.713, from individuals employed within
- 20 certified new jobs.
- 21 (p) "Written agreement" means a written agreement made between
- 22 the eligible business and the fund pursuant to this chapter.
- Sec. 90u. (1) The fund shall create and operate the Michigan
- 24 employment opportunity program to authorize the transfer of the
- 25 dedicated portion of withholding tax capture revenues to authorized
- 26 businesses that provide certified new jobs in this state. The fund
- 27 shall develop and use a detailed application, approval, and
- 28 compliance process published and available on the fund's website.
- 29 (2) An eligible business may apply to the fund to enter into a

- written agreement which authorizes the payment of withholding tax capture revenues under this chapter.
- 3 (3) The fund may request information, in addition to that
  4 contained in an application, as may be needed to permit the fund to
  5 discharge its responsibilities under this chapter.

- (4) After receipt of an application, the fund may enter into an agreement with an eligible business for withholding tax capture revenues under this chapter if the fund determines that all of the following are met:
- 10 (a) The eligible business proposes to create and maintain the 11 minimum number of certified new jobs at a facility in this state 12 and to pay an average annual wage that is described in section 13 90t(d).
  - (b) In addition to the jobs specified in subdivision (a), the eligible business, if already located within this state, agrees to maintain a number of full-time jobs equal to or greater than the number of full-time jobs it maintained in this state prior to the expansion, as determined by the fund.
- 19 (c) The plans for the expansion or location are economically 20 sound.
  - (d) The expansion or location of the eligible business will benefit the people of this state by increasing opportunities for employment and by strengthening the economy of this state.
  - (e) The withholding tax capture revenues offered under this chapter and paid from the employment opportunity fund are an incentive to expand or locate the eligible business in this state and address the competitive disadvantages with sites outside this state.
    - (f) An industry-recognized regional economic model cost-

- 1 benefit analysis reveals that the payment of withholding tax
- 2 capture revenues under this chapter to an eligible business will
- 3 result in an overall positive fiscal impact to the state.
- 4 (g) The eligible business will create the requisite number of
- 5 certified new jobs within not more than 5 years after entering into
- 6 the written agreement as determined by the fund.
- 7 (h) The eligible business will maintain the number of
- 8 certified new jobs throughout the duration of the period of time
- 9 that the authorized business receives withholding tax capture
- 10 revenues paid from the employment opportunity fund. However, if the
- 11 authorized business fails to maintain the requisite number of
- 12 certified new jobs as provided in the written agreement, the
- 13 authorized business will forfeit the withholding tax capture
- 14 revenues for that calendar year.
- 15 (i) That the local governing body of the municipality in which
- 16 the facility is located approves the expansion or new location by
- 17 resolution.
- 18 (5) If the fund determines that the eligible business
- 19 satisfies all of the requirements of subsection (4), subject to
- 20 subsection (6), the fund shall determine the amount and duration of
- 21 the withholding tax capture revenues to be authorized under this
- 22 chapter and shall enter into a written agreement as provided in
- 23 this section. The duration of the withholding tax capture revenues
- 24 must not exceed 5 or 10 years, whichever is applicable based on the
- 25 average annual wage of the certified new jobs, from the date the
- 26 authorized business creates the certified new jobs as provided in
- 27 the written agreement. Subject to subsection (6), in determining
- 28 the maximum amount and maximum duration of the withholding tax
- 29 capture revenues authorized, the fund shall consider the following

- 2 (a) The number of certified new jobs to be created.
- 3 (b) The degree to which the average annual wage of the 4 certified new jobs exceeds the prosperity region average wage.
- 5 (c) Whether there is a disadvantage to the eligible business 6 if it were to expand or locate in this state versus a site outside 7 this state.
- 8 (d) The potential impact of the expansion or location on the 9 economy of this state.
- 10 (e) The estimated cost of the reimbursement of withholding tax
  11 capture revenues under this chapter, the staff, financial, or
  12 economic assistance provided by the municipality, or local economic
  13 development corporation or similar entity, and the value of
  14 assistance otherwise provided by this state.
- 15 (f) Whether the expansion or location will occur in this state 16 without the payment of withholding tax capture revenues offered 17 under this chapter.
  - (g) Whether the eligible business has made a written commitment to fund some portion of costs for applicable training of the individuals who will perform the full-time jobs that leads to a professional or technical certification for these individuals.
  - (h) That the eligible business will make a good-faith effort to employ, if qualified, Michigan residents at the facility.
  - (6) The fund shall determine the duration and amount of the withholding tax capture revenues. In determining the duration of the withholding tax capture revenues, the fund shall provide a duration of up to 5 years for eligible businesses described in section 90t(d)(i)(B), (d)(ii)(B), or (d)(iii)(B) and up to a duration of 10 years for eligible businesses described in section

- 1 90t(d) (i) (A) or (C), (d) (ii) (A) or (C), or (d) (iii) (A) or (C). In
- 2 determining the amount of the withholding tax capture revenue
- 3 payments, the fund may approve a payment of not more than 50% of
- 4 the withholding tax capture revenues for an eligible business
- 5 described in section 90t(d)(i)(B), (d)(ii)(B), or (d)(iii)(B) and a
- 6 payment of up to 100% of the withholding tax capture revenues for
- 7 an eligible business described in section 90t(d)(i)(A) or (C),
- 8 (d) (ii) (A) or (C), or (d) (iii) (A) or (C). The amount of withholding
- 9 tax capture revenues certified to be paid to an authorized business
- 10 shall be reduced by 5%, which shall be retained by the fund for
- 11 additional administrative expenses under this chapter as provided

- 13 (7) A written agreement between an eliqible business and the
- 14 fund must include, but need not be limited to, all of the
- 15 following:
- 16 (a) A description of the business expansion or location that
- 17 is the subject of the written agreement.
- 18 (b) Conditions upon which the authorized business designation
- 19 is made.
- 20 (c) A statement from the eligible business that the eligible
- 21 business would not have added certified new jobs without the
- 22 withholding tax capture revenue payments authorized under this
- 23 chapter.
- 24 (d) An estimate of the amount of withholding tax capture
- 25 revenues expected to be generated for each calendar year of the
- 26 duration of the written agreement.
- (e) A statement by the eligible business that a violation of
- 28 the written agreement may result in the revocation of the
- 29 designation as an authorized business, the loss or reduction of

- 1 future withholding tax capture revenue payments under this chapter,
- 2 or a repayment of withholding tax capture revenues received
- 3 pursuant to this chapter.
- 4 (f) A statement by the eligible business that a
- 5 misrepresentation in the application may result in the revocation
- 6 of the designation as an authorized business and the repayment of
- 7 withholding tax capture revenues received under this chapter plus a
- 8 penalty equal to 10% of the withholding tax capture revenue
- 9 payments received pursuant to this chapter.
- 10 (g) A method for measuring and verifying full-time jobs before
- 11 and after an expansion or location of an authorized business in
- 12 this state.
- 13 (h) A provision that the authorized business that is certified
- 14 under section 90v(2) for a payment from the employment opportunity
- 15 fund shall file the required returns and reports under this chapter
- 16 and part 3 of the income tax act of 1967, 1967 PA 281, MCL 206.701
- 17 to 206.713, with the department of treasury, and shall provide any
- 18 other information reasonably requested by the fund or the
- 19 department of treasury.
- 20 (i) A maximum amount of withholding tax capture revenues that
- 21 the authorized business may claim before reduction of the 5%
- 22 payment described in section 90v for administrative expenses.
- 23 (8) Upon execution of a written agreement as provided in this
- 24 chapter, an eligible business is an authorized business. The fund
- 25 shall provide a copy of each written agreement to the department of
- 26 treasury. Upon execution of the written agreement, the transfer and
- 27 payment of withholding tax capture revenues as specified in this
- 28 chapter and in the written agreement are binding on this state. The
- 29 state treasurer shall calculate, based on the written agreements

- 1 received pursuant to this subsection, the amount of withholding tax
- 2 capture revenues collected as a result of the certified new jobs
- 3 created pursuant to those written agreements for each calendar year
- 4 and the percentage of that amount that needs to be transferred from
- 5 the general fund and deposited, in accordance with section 51f of
- 6 the income tax act of 1967, 1967 PA 281, MCL 206.51f, into the
- 7 employment opportunity fund, where the fund shall issue payments to
- 8 the authorized business in the manner provided in section 90v.
- 9 (9) The fund shall not commit, and the department of treasury
- 10 shall not disburse, an amount of total withholding tax capture
- 11 revenues that exceeds \$300,000,000.00 which includes the 5% payment
- 12 for administrative expenses as provided in section 90v. The fund
- 13 shall not execute more than 40 new written agreements each calendar
- 14 year for authorized businesses. If the fund approves fewer than 40
- 15 written agreements in a calendar year, then any unused written
- 16 agreements shall carry forward into future calendar years, and
- 17 shall be in addition to the annual limit that is otherwise
- 18 applicable. The fund shall not approve more than 10 written
- 19 agreements each year for authorized businesses in a tier 1 county
- 20 that total more than \$125,000,000.00, 15 written agreements each
- 21 year for authorized businesses in a tier 2 county that total more
- 22 than \$100,000,000.00, or 15 written agreements each year for
- 23 authorized businesses in a tier 3 county that total more than
- 24 \$75,000,000.00. For purposes of this subsection, "total withholding
- 25 tax capture revenues" means the aggregate amount of withholding tax
- 26 capture revenues that may be distributed to authorized businesses
- 27 under all written agreements.
- 28 (10) The fund shall not designate an authorized business or
- 29 enter into a new written agreement on or after December 31, 2026.

- Sec. 90v. (1) Subject to the limitations under section 90u(9), an authorized business is eligible to receive withholding tax capture revenue payments as provided in this chapter.
- 4 (2) Except as otherwise provided under subsection (3), the 5 fund shall issue a withholdings certificate each calendar year to 6 an authorized business that states the following:
  - (a) That the eligible business is an authorized business.

- 8 (b) The amount of withholding tax capture revenues to be paid
  9 from the employment opportunity fund for the designated calendar
  10 year.
- 11 (c) The authorized business's federal employer identification 12 number or the Michigan treasury number assigned to the authorized 13 business.
  - (3) The fund shall provide the department of treasury with a copy of each withholdings certificate issued under this section. Upon receipt of a withholdings certificate, an authorized business may request a payment from the employment opportunity fund by filing a copy of the withholdings certificate with the fund. The fund shall issue the withholding tax capture revenue payment from the employment opportunity fund within 90 days of receipt of the request for payment from the authorized business.
  - (4) If the authorized business subsequently fails to satisfy and maintain the minimum number of certified new jobs as required under this chapter or any other conditions included in the written agreement, the authorized business forfeits its withholding tax capture revenue payment for the calendar year that the authorized business fails to comply with this chapter or the written agreement. The forfeiture of a withholding tax capture revenue payment under this subsection does not extend the duration of the

- 1 original written agreement. Accordingly, if the duration of the
- 2 written agreement has not expired, an authorized business that
- 3 satisfies all of the terms of the written agreement after a
- 4 forfeiture under this subsection is entitled to certification for
- 5 withholding tax capture revenue payments for those subsequent

- 7 (5) In the event of a proposed reorganization, merger, or
