## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

2	Sec. 15101. As used in this part:
3	(a) "Over-the-counter drug" means a personal care product that
4	has a label under 21 CFR 201.66 identifying the product as a drug.
5	(b) "Personal care product" means an article intended to be

- 1 rubbed, poured, sprinkled, or sprayed on, introduced into, or
- 2 otherwise applied to the human body for cleansing, beautifying,
- 3 promoting attractiveness, or altering appearance, and any article
- 4 intended for use as a component of any such article. Personal care
- 5 product does not include a prescription drug.
- 6 (c) "Plastic" means a synthetic material made from linking
- 7 monomers through a chemical reaction to create an organic polymer
- 8 chain that can be molded or extruded at high heat into various
- 9 solid forms that retain their shapes during their life cycle and
- 10 after disposal.
- 11 (d) "Plastic microbead" means a plastic particle less than 5
- 12 millimeters in each dimension.
- 13 Sec. 15103. A person shall not do any of the following:
- 14 (a) Beginning January 1, 2022, manufacture for sale a personal
- 15 care product, except for an over-the-counter drug, that contains
- 16 intentionally added plastic microbeads.
- 17 (b) Beginning January 1, 2023, accept for sale a personal care
- 18 product, except for an over-the-counter drug, that contains
- 19 intentionally added plastic microbeads.
- 20 (c) Beginning January 1, 2023, manufacture for sale an over-
- 21 the-counter drug that contains intentionally added plastic
- 22 microbeads.
- 23 (d) Beginning January 1, 2025, accept for sale an over-the-
- 24 counter drug that contains intentionally added plastic microbeads.
- 25 Sec. 15105. (1) Subject to subsection (2), a person who
- 26 violates section 15103 may be ordered to pay a civil fine of not
- 27 more than \$1,000.00 per day for each over-the-counter drug or other
- 28 personal care product universal product code that is the subject of
- 29 a violation.

(2) A person who violates section 15103 a second or subsequent time may be ordered to pay a civil fine of not more than \$2,500.00 per day for each over-the-counter drug or other personal care product universal product code that is the subject of a violation.
