A bill to amend 1954 PA 116, entitled "Michigan election law,"

by amending sections 312 and 641 (MCL 168.312 and 168.641), section 312 as amended by 2013 PA 253 and section 641 as amended by 2015 PA 197.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 312. (1) A—Subject to subsection (3), a school board may
