PROVISIONS CONCERNING APPROPRIATIONS

GENERAL SECTIONS

Sec. 201. Pursuant to section 30 of article IX of the state constitution of 1963, total state spending from state sources under part 1 for the fiscal year ending September 30, 2022 is \$500,000.00 and total state spending from state sources to be paid to local units of government is \$0.00.

Sec. 202. The appropriations made and expenditures authorized under this part and part 1 and the departments, commissions, boards, offices, and programs for which appropriations are made under this part and part 1 are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

DEPARTMENT OF CIVIL RIGHTS

Sec. 301. (1) Funds appropriated in part 1 for Michigan fair chance access to housing must be used by the department of civil rights to implement and administer the Michigan fair chance access to housing act. Funds may be used to hire staff to process and investigate complaints under the act.

(2) The unexpended funds appropriated in part 1 for Michigan fair chance access to housing are designated as a work project

- appropriation. Any unencumbered or unallotted funds shall not lapse at the end of the fiscal year and shall be available for expenditures for projects under this section until the projects have been completed. The following is in compliance with section 451a of the management and budget act, 1984 PA 431, MCL 18.1451a:
 - (a) The purpose of the project is to implement and administer the Michigan fair chance access to housing act.
 - (b) The project will be accomplished by utilizing state employees or contracts, or both.
 - (c) The total estimated cost of the project is \$500,000.00.
