A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1308c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1308c. (1) By not later than July 1, 2023, the department of state police shall promulgate rules, in compliance with the
- 3 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to
- 4 24.328, establishing a standardized response terminology plan and
- 5 provide the plan, as established in rule, to public schools and 6 nonpublic schools. The standardized response terminology plan
- 7 described in this subsection must include, at a minimum, all of the

- 2 (a) Direction concerning terminology that should be utilized
- 3 by public schools and nonpublic schools in response to certain
- 4 situations that occur in or at a school building operated by the
- 5 public school or nonpublic school, including, but not limited to,
- 6 the following direction concerning terminology, as described in
- 7 this subdivision:
- 8 (i) That the term "lockdown" should be used when there is an
- 9 existing threat in or at a school building or a threat is expected
- 10 to arrive in or at a school building imminently.
- 11 (ii) That the term "secure mode" should be used when it is
- 12 determined that a lockdown, as described in subparagraph (i), is not
- 13 necessary but heightened security is needed due to a potential
- 14 external threat. Under "secure mode", as described in this
- 15 subparagraph, instruction must continue in a normal manner, but
- 16 access to the school building, movement throughout the school
- 17 building, and pupil or student activities must be limited and
- 18 monitored.
- 19 (iii) That the term "shelter in place" should be used when
- 20 conditions are safer inside a school building than outside of the
- 21 school building. These conditions include, but are not limited to,
- 22 certain severe weather conditions or hazardous-materials incidents
- 23 that are in close proximity to the school building.
- (iv) That the term "reverse evacuation" should be used when
- 25 pupils or students enrolled in the public school or nonpublic
- 26 school and school staff need to move rapidly, but in a systemic
- 27 fashion, from an outdoor area to an indoor area where they can be
- 28 protected from a threat.
- 29 (v) That the term "room clear" should be used when pupils or

- 1 students enrolled in the public school or nonpublic school need to
- 2 be evacuated from a specific place in a school building to a safer
- 3 location in the school building to protect them from harm or to
- 4 enable school employees and workers and first responders to address
- 5 any incidents.
- 6 (b) Direction providing that all public schools and nonpublic
- 7 schools should be in "secure mode" as described in subdivision (a)
- 8 when instruction is being provided.
- 9 (c) Direction concerning the use of a color-coding system to
- 10 indicate when the terminology described in subdivision (a) should
- 11 be in use at a public school or nonpublic school.
- 12 (2) As used in this section, "school building" means any of
- 13 the following:
- 14 (a) A building intended to be used to provide instruction for
- 15 pupils or students, including an addition to an existing building.
- 16 (b) A recreational or athletic structure or field intended to
- 17 be used by pupils.
