SENATE CONCURRENT RESOLUTION NO. 34

Senator Shirkey offered the following concurrent resolution: A concurrent resolution of tribute offered as a memorial for 1 2 Joanne Emmons, former member of the House of Representatives and 3 the Senate. Whereas, It was with great sorrow that the members of the 4 Michigan Legislature learned about the passing of Joanne Emmons. 5 She will be remembered as an exceptional public servant who 6 7 tirelessly advocated for her constituents in Mecosta County and the 8 surrounding area; and Whereas, Joanne Emmons was born in 1934 on the family farm. 9 10 After graduating as valedictorian from Mecosta High School in 1952, she went on to obtain a bachelor's degree in home economics from 11 12 Michigan State University in 1956. She married John Emmons that 13 summer and began her lengthy career as a public servant shortly 14 thereafter. After she taught home economics at her high school alma

- 1 mater for three years, she later became Deputy Treasurer for Big
- 2 Rapids Township. Joanne Emmons successfully ran for treasurer of
- 3 Big Rapids Township, where she served for ten years. She
- 4 volunteered with many organizations including Mecosta Farm Bureau,
- 5 Area Agency on Aging Advisory Board, St. Peter's School Board and
- 6 Council, Mecosta County Right to Life, Michigan Maple Syrup
- 7 Association, Mecosta County Area Chamber of Commerce, Mt. Pleasant
- 8 Area Chamber of Commerce, Christian Women's Club, and the Omicron
- 9 Nu Honor Society. During that time, she also held leadership
- 10 positions in several organizations, including Chair of the Mecosta
- 11 County Republican Party, member of the board of directors of the
- 12 Michigan Townships Association, member of the Michigan Municipal
- 13 Treasurer's Association, Chair of the Big Rapids Township
- 14 Sesquicentennial, and Secretary of the Central Michigan Mental
- 15 Health Board. In 1987, she began her first of five terms with the
- 16 Michigan Legislature; and
- 17 Whereas, Joanne Emmons completed two terms in the House of
- 18 Representatives, followed by three terms in the Senate. During her
- 19 time in the House, she served as minority vice chair of the House
- 20 Committee on Colleges and Universities, as well as a member of the
- 21 House committees on Elections; Senior Citizens and Retirement;
- 22 Taxation; and Civil Rights. During her time in the Senate, she held
- 23 leadership positions on many committees, including the Senate
- 24 committees on Mental Health, Human Resources, and Senior Citizens;
- 25 Technology and Energy; Finance; Labor; Government Operations;
- 26 Education; and Financial Services, in addition to serving on the
- 27 Legislative Retirement Board of Trustees; Legislative Council;
- 28 Joint Committee on Administrative Rules; and the committees on
- 29 Reapportionment and Banking and Financial Institutions. Notably,

- 1 Senator Emmons broke several glass ceilings when she became the
- 2 first woman to chair the Senate Finance Committee and became the
- 3 first woman to serve as Senate Majority Floor Leader. Senator
- 4 Emmons also served as Senate Majority Whip; and
- 5 Whereas, After retiring from the Senate, Joanne Emmons
- 6 continued to serve her community in a variety of capacities. She
- 7 took a prominent role as the chair of the board of directors at the
- 8 Russell Kirk Center, where she focused on sharing and expanding
- 9 conservative thought. She also continued her work with Michigan
- 10 Right to Life, advocating for the rights of the unborn. Joanne
- 11 Emmons was also able to spend time doing activities she loved:
- 12 traveling, enjoying her family, and gardening; and
- 13 Whereas, Joanne Emmons, described by her former colleagues as
- 14 a remarkable stateswoman, leaves behind a legacy as a highly
- 15 respected and effective legislator. Throughout her career, she
- 16 sponsored bills on a wide variety of topics, and was particularly
- 17 influential in changing Michigan's tax law. Though she stayed true
- 18 to her conservative values, Joanne Emmons was also known for being
- 19 adept at working with legislators across the political spectrum.
- 20 Her unwavering dedication to her constituents, fierce work ethic,
- 21 senses of humor and fairness, and ability to mentor others remain
- 22 an example of what it takes to be a successful public servant; and
- 23 Whereas, Upon her passing, we offer condolences to her family
- 24 and friends. We hope they take comfort in the knowledge that her
- 25 contributions will long continue to enrich the people of this
- 26 state; now, therefore, be it
- 27 Resolved by the Senate (the House of Representatives
- 28 concurring), That we offer this expression of our highest tribute
- 29 to honor the memory of Joanne Emmons, a member of the House of

- 1 Representatives from 1987 to 1990 and the Senate from 1991 to 2002;
- 2 and be it further
- 3 Resolved, That copies of this resolution be transmitted to the
- 4 Emmons family as evidence of our lasting esteem for her memory.
