- 7 Olympics, and a dedicated member of the St. Clair Shores Waterfront
- 8 Environmental Committee. Representative Hertel is also the devoted
- 9 husband to his wife, Ann, and loving father to their sons, William
- 10 and Benjamin; and
- 11 Whereas, Representative Hertel's legislative record stands as
- 12 a testament to his dedication to this state and the citizenry of
- 13 the Eighteenth District. Representative Hertel served with
- 14 distinction as the minority vice chair of both the Oversight and
