SENATE RESOLUTION NO.156

Senators Chang, Alexander, Bayer, Geiss, Moss, Polehanki, Santana and Wojno offered the following resolution:

- 1 A resolution to commemorate June 23, 2022, as the 40th
- 2 anniversary of Vincent Chin's death.
- 3 Whereas, Vincent Chin was born in the Guangdong province of
- 4 China on May 18, 1955. In 1961, he was adopted from a Chinese
- 5 orphanage by Bing Hing Chin and Lily Chin; and
- 6 Whereas, Chin's father earned the ability for his wife to
- 7 immigrate to the United States from his service in the United
- 8 States Army during World War II; and
- 9 Whereas, Chin was raised in Highland Park, Michigan along
- 10 Woodward Avenue until 1971 when his family moved to Oak Park. He
- 11 graduated from Oak Park High School in 1973; and

- 1 Whereas, In 1982, Chin was employed as an industrial draftsman
- 2 by an automotive supplier, worked weekends as a waiter in Ferndale,
- 3 and was engaged to be married; and
- 4 Whereas, On June 19, 1982 in Highland Park, while celebrating
- 5 his upcoming nuptials, Chin was attacked because of his race; and
- 6 Whereas, At a time when Japanese auto companies were thriving
- 7 and the American auto industry was struggling, two former
- 8 autoworkers mistook Chin for being Japanese and verbally harassed
- 9 him, using racially motivated language; and
- 10 Whereas, Later that day, the same two men followed Chin to a
- 11 nearby fast food restaurant. They bludgeoned Chin with a baseball
- 12 bat until his skull cracked open; and
- 13 Whereas, Four days later on June 23 1982, Chin died at Henry
- 14 Ford Hospital at the age of 27; and
- 15 Whereas, The two killers were convicted of manslaughter,
- 16 sentenced to three years of probation, and fined \$3,000. Their
- 17 sentences were considered by many to be an injustice, considering
- 18 the severity of the crime; and
- 19 Whereas, Chin's attorneys brought federal charges regarding
- 20 the violation of Chin's civil rights and successfully settled a
- 21 civil case for unlawful death; and
- Whereas, The hate crime and tragic killing of Vincent Chin
- 23 sparked a pan-Asian American movement in Detroit. Asian Americans
- 24 of all ethnic groups came together to address injustice; and
- 25 Whereas, In the wake of Chin's killing, American Citizens for
- 26 Justice (ACJ) was founded in Michigan. ACJ organized rallies and
- 27 events to advocate for equal justice for all; and
- Whereas, 40 years after Chin's death, there are parallels
- 29 between the anti-Asian sentiment that existed in the 1980s and the

- 1 current, ongoing wave of anti-Asian hate incidents and
- 2 discrimination due to the COVID-19 pandemic; and
- 3 Whereas, Asian Americans and their allies mark this 40th
- 4 anniversary as an important opportunity for continued advocacy for
- 5 equal justice and to stand against hate and discrimination; and
- 6 Whereas, We remember Vincent Chin and the legacy of the civil
- 7 rights activism that originated from his tragic death; now,
- 8 therefore, be it
- 9 Resolved by the Senate, That the members of this legislative
- 10 body commemorate June 23, 2022, as the 40th anniversary of Vincent
- 11 Chin's death.
