HOUSE RESOLUTION NO.326

Rep. Tate offered the following resolution:

- 1 A resolution to strongly urge the United States Air Force to
- 2 replace the fleet of A-10 Thunderbolt Attack Fighters at Selfridge
- 3 Air National Guard Base with an advanced generation fighter
- 4 mission.
- 5 Whereas, Selfridge Air National Guard Base (ANGB) is
- 6 intrinsically designed to meet the priorities of the 2022 National
- 7 Defense Strategy. Selfridge offers an immediate fighter aircraft
- 8 basing solution with existing infrastructure, manpower, and
- 9 unconstrained access to advanced multi-domain training ranges. A
- 10 fighter mission at Selfridge complements Michigan's National All
- 11 Domain Warfighting Center which prepares warfighters for future
- 12 conflicts against peer adversaries, and is strategically located
- 13 between 42 and 48 degrees latitude. Michigan is the backstop for

- 1 Defense of the Homeland and is capable of projecting power in all
- 2 domains through a combat-credible force, in cooperation with allies
- 3 and partners; and
- 4 Whereas, Selfridge ANGB has a long and proud history of flying
- 5 fighter aircraft dating back almost 100 years. The base is home to
- 6 the 127th Wing, a highly respected warfighting unit currently
- 7 flying A-10s and KC-135s. The 127th Wing has been essential in
- 8 providing combat air support to the Middle East in recent years;
- 9 and
- 10 Whereas, Selfridge ANGB is a joint military community with
- 11 existing infrastructure; efficient flight times to the largest
- 12 overland airspace complex east of the Mississippi River;
- 13 significant overwater and littoral training opportunities, and easy
- 14 access to northern Michigan training facilities in Alpena and
- 15 Grayling; and
- 16 Whereas, Selfridge ANGB is located north of Detroit on the
- 17 shore of Lake Saint Clair and is in close proximity to the Detroit
- 18 metropolitan area and a major airline hub. The base offers a focal
- 19 point for gaining and retaining the highest quality pilots and
- 20 maintenance personnel; and
- 21 Whereas, Divestment of the A-10 fleet in fiscal year 2027 will
- 22 result in a loss of 21 aircraft and 611 personnel, including 246
- 23 full-time employees. This will result in a negative economic impact
- 24 of about \$44,520,000 annually to the State of Michigan; and
- 25 Whereas, Selfridge ANGB is a source of community pride and
- 26 jobs, with a local economic benefit worth hundreds of millions of
- 27 dollars to residents and businesses in several surrounding cities
- 28 and townships. In addition, the base is a key component of disaster
- 29 response for the entire state and a vital base for our nation's

- 1 homeland defense; now, therefore, be it
- 2 Resolved by the House of Representatives, That we strongly
- 3 urge the United States Air Force to replace the fleet of A-10
- 4 Thunderbolt Attack Fighters at Selfridge Air National Guard Base
- 5 with an advanced generation fighter mission; and be it further
- 6 Resolved, That copies of this resolution be transmitted to the
- 7 Michigan congressional delegation and the Secretary of the Air
- 8 Force.
