## SENATE RESOLUTION NO.173

Senators Shirkey and Ananich offered the following resolution:

- 1 A resolution of tribute for the Honorable Doug Wozniak.
- 2 Whereas, It is with gratitude that we recognize Senator Doug
- 3 Wozniak for his work on behalf of the citizens of Michigan and, in
- 4 particular, his constituents in the Eighth District. Throughout his
- 5 tenure, Senator Wozniak's hard work has benefited not only the
- 6 residents of the cities of St. Clair Shores, Utica, and Mt.
- 7 Clemens, the village of Grosse Pointe Shores, and Bruce,
- 8 Washington, Ray, Lenox, Chesterfield, Harrison, and Shelby
- 9 townships, but all of Michigan's citizens; and
- 10 Whereas, Before assuming office in 2021, Senator Wozniak
- 11 attained a bachelor's degree in mathematics from the University of
- 12 Michigan and a juris doctor degree from Michigan State University's
- 13 College of Law. Senator Wozniak's prior experiences as the founder

- 1 of the Law Offices of Douglas C. Wozniak, PLC, the Wozniak Law
- 2 Office, and the Wozniak Realty Associates are a testament to the
- 3 personal drive and work ethic that were reflected in his service to
- 4 our Senate. Senator Wozniak also served as the trustee of the
- 5 Charter Township of Shelby for ten years, from 2008 to 2018.
- 6 Senator Wozniak's commitment to his community is further reflected
- 7 by active membership in local organizations including the Shelby
- 8 Golden K Kiwanis, Shelby Optimists, St. Kieran Knights of Columbus,
- 9 Grosse Pointe Crisis Club, and the Shelby Lions. Before assuming
- 10 his role in this chamber, Senator Wozniak also served as a member
- 11 of the Michigan House of Representatives from 2019 to 2021; and
- 12 Whereas, Senator Wozniak was elected to the Senate in a
- 13 special election in 2021 and has dutifully served the Senate as a
- 14 member of the committees on Energy and Technology; Families,
- 15 Seniors, and Veterans; Judiciary and Public Safety; and
- 16 Transportation and Infrastructure. During his tenure, he sponsored
- 17 successful legislation to expand the ability of former employees to
- 18 seek administrative and judicial relief from decisions made by the
- 19 Municipal Employees Retirement System, requiring that their voices
- 20 be heard by providing for hearings under the Administrative
- 21 Procedures Act. Senator Wozniak's contributions to this legislative
- 22 body would not have been possible without the loving support of his
- 23 family, including the Honorable Senator's wife of 39 years, Pamela,
- 24 and his daughter, Dr. Lauren Wozniak; now, therefore, be it
