- 2 Whereas, The members of this chamber commend the Honorable Kim
- 3 LaSata as her time representing the Twenty-first District in the
- 4 Michigan Senate comes to a close. Since stepping into her role in
- 5 2019, Senator LaSata has served Michigan's citizens with
- 6 distinction, especially her constituents in Berrien, Cass, and St.
- 7 Joseph counties as their first female Senator; and
- 8 Whereas, Senator LaSata's professional and educational
- 9 background provided a basis for her success in carrying out the
- 10 duties of her office. Senator LaSata holds a bachelor's degree in
- 11 education as well as a master's degree in literacy studies from
- 12 Western Michigan University. Her prior experiences as a teacher in
- 13 her alma mater, the Lake Michigan Catholic School System for

- 1 which she was selected Teacher of the Year in 2015 have been
- 2 invaluable in her work in this legislative body. Senator LaSata's
- 3 commitment to her community is demonstrated through her service as
- 4 president of the Women's Service League in Berrien County, of
- 5 Berrien County Guardianship Services, Inc., and of the Capstone
- 6 Center and as vice-chair of Child and Family Services-Southwest.
- 7 Before assuming her role in the Senate, Senator LaSata served as a
- 8 member of the Michigan House of Representatives from 2017 to 2018.
- 9 Senator LaSata is also the devoted wife to her husband, Charlie,
- 10 who formerly served in the House, and loving mother to four
- 11 children: Sarah, Anna, Chas, and Claire; and
- 12 Whereas, Senator LaSata's service to this chamber is a
- 13 testament to the dedication she holds for her constituency. Senator
- 14 LaSata served as chair of the Appropriations subcommittee on
- 15 Universities and Community Colleges as well as vice chair of the
- 16 Transportation and Infrastructure Committee, the Advice and Consent
- 17 Committee, and the Appropriations subcommittee on Capital Outlay.
- 18 In addition, Senator LaSata actively served as a member of the
- 19 Appropriations subcommittee on Community Health/Human Services and
- 20 the committees on Economic and Small Business Development, Energy
- 21 and Technology, Health Policy and Human Services, and Insurance and
- 22 Banking. During her time in this chamber, the Senator championed
- 23 legislation to establish new scholarship opportunities for students
- 24 across the state as well as to honor the legacy of police officers
- 25 fallen in the line of duty. Throughout her tenure, Senator LaSata
- 26 proved to be a committed servant to Michiganians everywhere and a
- 27 leader in this legislative body, as evidenced by her election and
- 28 service as Assistant Majority Floor Leader; now, therefore, be it
