THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 232a. (1) Except as provided in subsection (2), a person

- 5 (2) (3) A person An individual who intentionally makes a
- 6 material false statement on an application for a license to

- 8 guilty of a felony punishable by imprisonment for not more than 4
- 9 years or a fine of not more than \$2,000.00, or both.
