- 6 Representative Hood also served as the executive director of the
- 7 West Michigan Environmental Action Council for a decade, working to
- 8 improve stormwater management and promote clean energy solutions;

- 10 Whereas, Elected to represent the Seventy-sixth District in
- 11 2018, and now serving the Eighty-first District, Representative
- 12 Hood has continued her work as an advocate for the environment. She
- 13 introduced legislation to facilitate community solar programs,
- 14 strengthen penalties for those who might endanger the Straits of
- 15 Mackinac by damaging underwater energy infrastructure, and protect
- 16 our state's iconic sand dunes from potentially risky developments.
- 17 Alongside her work on these and other policies, Representative
- 18 Hood's committee work has focused on the appropriations process. A
- 19 member of the Committee on Appropriations, her experience was
- 20 recognized when she was made chair of the Environment, Great Lakes,

- 22 Subcommittee, and minority vice chair of the Agriculture and Rural
- 23 Development and Natural Resources Subcommittee. She has also served
- 24 as a member of the Appropriations subcommittees on Health and Human
