HOUSE BILL NO. 4213

March 12, 2025, Introduced by Reps. Hoadley, DeSana, Greene, BeGole, Fox, Woolford, DeBoyer, Paquette, Harris, St. Germaine, Cavitt, Maddock, Wortz and Thompson and referred to Committee on Government Operations.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices; to prohibit the buying, selling, or carrying of certain firearms, gas ejecting devices, and electro-muscular disruption devices without a license or other authorization; to provide for the forfeiture of firearms and electro-muscular disruption devices under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

by amending section 50 (MCL 28.4250), as amended by 2017 PA 95.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 50. (1) Subject to subsection (5), an individual licensed under this act to carry a concealed pistol, or who is exempt from licensure under section 12a(h), shall not carry a concealed pistol on the premises of any of the following:
- 6 guardian of a student of the school is not precluded from carrying
 7 a concealed pistol while in a vehicle on school property, if he or
 8 she is dropping the student off at the school or picking up the

The Michigan liquor control commission shall develop 22 and make available to holders of licenses under the Michigan liquor 23 control code of 1998, 1998 PA 58, MCL 436.1101 to 436.2303, an 24 appropriate sign stating that "This establishment prohibits patrons 25 from carrying concealed weapons". The owner or operator of an establishment licensed under the Michigan liquor control code of 26 27 1998, 1998 PA 58, MCL 436.1101 to 436.2303, may post the sign

- 11 high a seating capacity of 2,500 or more individuals.

- (h) A dormitory or classroom of a community college, college,

- 15 (2) Subject to subsection (5), an individual shall not carry a
- 16 portable device that uses electro-muscular disruption technology on
- 17 any of the premises described in subsection (1).
- 18 (3) An individual licensed under this act to carry a concealed
- 19 pistol, or who is exempt from licensure under section 12a(h), shall
- 20 not carry a concealed pistol in violation of R 432.1212 of the
- 21 Michigan Administrative Code promulgated under the Michigan gaming
- 22 control Gaming Control and revenue act, Revenue Act, 1996 IL 1, MCL
- **23** 432.201 to 432.226.
- 24 (4) As used in subsection (1), "premises" does not include
- 25 parking areas of the places premises identified under subsection
- **26** (1).
- 27 (5) Subsections (1) and (2) do not apply to any of the
- 28 following:
- 29 (a) An individual licensed under this act who is a retired

- police officer, retired law enforcement officer, or retired federal
 law enforcement officer.
- 3 (b) An individual who is licensed under this act and who is
- 4 employed or contracted by an entity described under subsection (1)
- 5 to provide security services and is required by his or her the
- 6 individual's employer or the terms of a contract to carry a
- 7 concealed firearm on the premises of the employing or contracting
- 8 entity.
- **9** (c) An individual who is licensed as a private investigator or
- 10 private detective under the professional investigator licensure
- 11 act, 1965 PA 285, MCL 338.821 to 338.851.
- 12 (d) An individual who is licensed under this act and who is a
- 13 corrections officer of a county sheriff's department or who is
- 14 licensed under this act and is a retired corrections officer of a
- 15 county sheriff's department, if that individual has received county
- 16 sheriff approved weapons training.
- 17 (e) An individual who is licensed under this act and who is a
- 18 motor carrier officer or capitol security officer of the department
- 19 of state police.
- 20 (f) An individual who is licensed under this act and who is a
- 21 member of a sheriff's posse.
- 22 (g) An individual who is licensed under this act and who is an
- 23 auxiliary officer or reserve officer of a police or sheriff's
- 24 department.
- 25 (h) An individual who is licensed under this act and who is
- 26 any of the following:
- 27 (i) A parole, probation, or corrections officer, or absconder
- 28 recovery unit member, of the department of corrections, if that
- 29 individual has obtained a Michigan department of corrections

- 1 weapons permit.
- (ii) A retired parole, probation, or corrections officer, or
- 3 retired absconder recovery unit member, of the department of
- 4 corrections, if that individual has obtained a Michigan department
- 5 of corrections weapons permit.
- 6 (i) A state court judge or state court retired judge who is
- 7 licensed under this act.
- 8 (j) An individual who is licensed under this act and who is a
- 9 court officer.
- 10 (k) An individual who is licensed under this act and who is a
- 11 peace officer.
- 12 (6) An individual who violates this section subsection (1),
- 13 (2), or (3) is responsible for a state civil infraction or guilty
- 14 of a crime as follows:
- 15 (a) Except as provided in subdivisions (b) and (c), the
- 16 individual is responsible for a state civil infraction and may be
- 17 fined not more than \$500.00. The court shall order the individual's
- 18 license to carry a concealed pistol suspended for 6 months.
- 19 (b) For a second violation, the individual is quilty of a
- 20 misdemeanor punishable by a fine of not more than \$1,000.00. The
- 21 court shall order the individual's license to carry a concealed
- 22 pistol revoked.
- 23 (c) For a third or subsequent violation, the individual is
- 24 quilty of a felony punishable by imprisonment for not more than 4
- 25 years or a fine of not more than \$5,000.00, or both. The court
- 26 shall order the individual's license to carry a concealed pistol
- 27 revoked.
- 28 (7) The owner or operator of any premises not described in
- 29 subsection (1) or (3) that prohibits an individual from carrying a

- 1 concealed pistol on those premises shall ensure that the premises
- 2 include all of the following when the premises are open to the
- 3 public:

- (a) Metal detectors at every entrance to the premises.
- 5 (b) The presence of an individual employed by or contracted by
- 6 the owner or operator to provide security services on the premises.
