A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 18509 (MCL 333.18509), as amended by 2004 PA 61.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 18509. (1) Except as otherwise provided in section 18515,
- 2 an individual granted a license under this part shall meet the
- 3 following requirements:
- 4 (a) A licensed bachelor's social worker shall have been

- 1 awarded a bachelor's degree in social work from a college or
- 2 university social work program approved by the board and shall have
- 3 completed at least 2 years of full-time postbachelor's degree
- 4 experience, or the equivalent in part-time hours, in the practice
- 5 of social work at the bachelor's level under the supervision of a
- 6 licensed master's social worker. Until July 1, 2008, the required
- 7 experience in the practice of social work at the bachelor's level
- 8 shall must be performed under the supervision of a person an
- ${f 9}$ individual who has been awarded a master's or doctoral degree in
- 10 social work from a college or university school of social work.
- 11 (b) A licensed master's social worker shall have been awarded
- 12 a master's or doctoral degree in the field of social work from a
- 13 college or university social work program approved by the board and
- 14 shall have completed at least 2 years of full-time postmaster's or
- 15 postdoctoral degree experience, or the equivalent in part-time
- 16 hours, in the practice of social work at the master's level under
- 17 the supervision of a licensed master's social worker. Until July 1,
- 18 2008, the required experience in the practice of social work at the
- 19 master's level shall must be performed under the supervision of a
- 20 person an individual who has been awarded a master's or doctoral
- 21 degree in the field of social work from a college or university
- 22 school of social work and has engaged in the practice of social
- 23 work for not less than 2 years. In addition to the requirements set
- 24 forth in this subdivision, a licensed master's social worker
- 25 employed by a school district shall meet the requirements for
- 26 employment as a school social worker contained in the revised
- 27 school code, 1976 PA 451, MCL 380.1 to 380.1852, and the rules

- 29 (2) The board may grant a limited license to engage in the 2-

- 1 year postdegree experience required under subsection (1) to an
- 2 individual who has completed all the educational requirements for
- 3 licensure as a bachelor's social worker or a master's social
- 4 worker. A limited license granted under this subsection is
- 5 renewable for not more than 6-10 years.
