## **HOUSE BILL NO. 4400**

April 29, 2025, Introduced by Reps. Meerman and DeSana and referred to Committee on Government Operations.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 697c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 697c. (1) A dealer or distributor shall not sell or offer
- 2 for sale or operate any vehicle in this state that is designed,
- 3 developed, or manufactured by a foreign entity of concern.
- 4 (2) A dealer or distributor that violates this section is
- 5 subject to a civil fine of not more than \$50,000.00 per violation.
- 6 In addition to a civil fine under this subsection, a vehicle sold

- 1 or owned in violation of this section is subject to seizure and
- 2 forfeiture.
- 3 (3) As used in this section, "foreign entity of concern" means
- 4 a foreign entity that is any of the following:
- 5 (a) Designated as a foreign terrorist organization under 8 USC
- 6 1189.
- 7 (b) Included on the list of specially designated nationals and
- 8 blocked persons maintained by the Office of Foreign Assets Control
- 9 of the United States Department of Treasury.
- 10 (c) Owned by, controlled by, or subject to the jurisdiction or
- 11 direction of a government of a foreign country that is a covered
- 12 nation as that term is defined in 10 USC 4872.
- 13 (d) Alleged by the attorney general to have been involved in
- 14 an activity for which a conviction was obtained under any of the
- 15 following:
- 16 (i) The espionage act of 1917, 18 USC 792 to 799.
- 17 (ii) 18 USC 951 and 1030.
- 18 (iii) The economic espionage act of 1996, 18 USC 1831 to 1839.
- 19 (iv) The arms export control act, 22 USC 2751 to 2799aa-2.
- 20 (v) 42 USC 2274 to 2277 and 2284.
- 21 (vi) The export control reform act, 50 USC 4801 to 4852.
- (vii) The international emergency economic powers act, 50 USC
- 23 1701 to 1710.
- 24 (e) The People's Republic of China.
- 25 (f) The Russian Federation.
- 26 (g) The Islamic Republic of Iran.
- 27 (h) The Democratic People's Republic of Korea.
- 28 (i) Cuba.
- 29 (j) The Venezuelan regime of Nicolas Maduro.

- 1 (k) The Syrian Arab Republic.
- 2 (l) An agency or entity that is under significant control of a 3 country listed under subparagraphs (e) to (k).
- 4 Enacting section 1. This amendatory act takes effect 90 days 5 after the date it is enacted into law.
