SENATE BILL NO. 620

October 22, 2025, Introduced by Senators GEISS, ANTHONY, SHINK and CAVANAGH and referred to Committee on Transportation and Infrastructure.

A bill to regulate relying parties on mobile licenses; and to provide for the powers and duties of certain state and local governmental officers and entities.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act may be cited as the "relying parties on
- 2 mobile licenses act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Data elements" means a distinct component of an
- 5 individual's information that is found on the records of the

- 1 department.
- 2 (b) "Department" means the department of state.
- 3 (c) "Holder" means an individual that is issued, and presents
- 4 to a relying party, any of the following:
- $\mathbf{5}$ (i) A mobile enhanced driver license or mobile enhanced
- 6 official state personal identification card.
- 7 (ii) A mobile official state personal identification card.
- 8 (iii) A mobile operator's or chauffeur's license.
- 9 (d) "Mobile enhanced driver license or mobile enhanced
- 10 official state personal identification card" means a mobile
- 11 enhanced driver license or mobile enhanced official state personal
- 12 identification card issued under section 4 of the enhanced driver
- 13 license and enhanced official state personal identification card
- 14 act, 2008 PA 23, MCL 28.304.
- 15 (e) "Mobile official state personal identification card" means
- 16 a mobile official state personal identification card issued under
- 17 section 2 of 1972 PA 222, MCL 28.292.
- (f) "Mobile operator's or chauffeur's license" means a mobile
- 19 operator's or chauffeur's license issued under section 310a of the
- 20 Michigan vehicle code, 1949 PA 300, MCL 257.310a.
- 21 (g) "Provision" means that term as defined in section 310a of
- 22 the Michigan vehicle code, 1949 PA 300, MCL 257.310a.
- (h) "Relying party" means a person that is presented with and
- 24 chooses to rely on a mobile operator's or chauffeur's license, a
- 25 mobile official state personal identification card, or a mobile
- 26 enhanced driver license or mobile enhanced official state personal
- 27 identification card.
- 28 (i) "Secretary of state" means the secretary of state of this
- 29 state, acting directly or through the secretary of state's duly

- 1 authorized deputy, investigators, agents, and employees.
- 2 Sec. 5. (1) During a transaction, a relying party shall do all 3 of the following:
- 4 (a) Request only data elements from a mobile operator's or 5 chauffeur's license, mobile official state personal identification 6 card, or mobile enhanced driver license or mobile enhanced official 7 state personal identification card that are available on the mobile 8 operator's or chauffeur's license, mobile official state personal 9 identification card, or mobile enhanced driver license or mobile 10 enhanced official state personal identification card and necessary 11 to complete the transaction for which the data is being requested.
- 12 (b) Inform the holder of the use and retention of any
 13 requested data elements in the event that the relying party seeks
 14 to retain the data elements.
- (c) Obtain the consent of the holder for the release and, if applicable, the retention of all the data elements requested before the release and retention of any of those data elements.
 - (d) Cryptographically authenticate a mobile operator's or chauffeur's license, mobile official state personal identification card, or mobile enhanced driver license or mobile enhanced official state personal identification card before accepting the mobile operator's or chauffeur's license, mobile official state personal identification card, or mobile enhanced driver license or mobile enhanced official state personal identification card.
- 25 (e) Adhere to all applicable privacy laws and regulations.
 26 Data contained in a mobile operator's or chauffeur's license,
 27 mobile official state personal identification card, or mobile
 28 enhanced driver license or mobile enhanced official state personal
 29 identification card is subject to all applicable privacy laws and

- 2 (2) Except as otherwise provided under the Michigan vehicle

- 17 (c) Require the presentation of a mobile operator's or
- 18 chauffeur's license, mobile official state personal identification
- 19 card, or mobile enhanced driver license or mobile enhanced official
- 20 state personal identification card for the completion of any
- 21 transaction.
- 22 Sec. 7. Presentation or use of a mobile operator's or
- 23 chauffeur's license, mobile official state personal identification
- 24 card, or mobile enhanced driver license or mobile enhanced official
- 25 state personal identification card for identity verification or
- 26 other permitted purposes does not constitute consent or
- 27 authorization for a relying party to search, view, or access any
- 28 other data or application on the mobile device.
